

Advisory Council on Student Behavior and Discipline (ACSBD)

Legislative Report

December 2018

The ACSBD Legislative Report serves as fulfillment of requirements specified in Act 600 of 2018 directing the ACSBD to review current state laws, policies, and regulations and submit its findings and recommendations to the Senate Committee on Education, the House Committee on Education and the state senator who represents Senate District No. 4, not later than February 15, 2019.

Pursuant to La. R.S. 17:253, the ACSBD 2018 Annual Report will be a separate report to the Senate Committee on Education, the House Committee on Education, and the State Board of Elementary and Secondary Education (BESE) with findings and recommendations with respect to the implementation of school master plans for improving student behavior and discipline as provided in R.S. 17:252.

Since the 2018 Legislative Session, the full ACSBD convened four times (June 5th, August 24th, October 12th, and December 7th, 2018). The ACSBD Legislative Workgroup convened three additional times (July 13th, September 7th, and November 16th, 2018). During these meetings, a diverse set of stakeholders worked together to reach compromise and consensus on a set of recommended principles and specific language changes to improve Louisiana laws related to student behavior and discipline. The ACSBD refined a set of principles to guide development of and revision of state laws and policies related to student behavior (see Appendix I). The entire set of state laws, policies and regulations related to student behavior and discipline were reviewed and considered (See Appendices III and IV).

The ACSBD recommends for the 2019 Legislative Session, the Louisiana Legislature consider revising the primary Louisiana statute related to student behavior and discipline, La. R.S. 17:416, to ensure it aligns with the Principles developed and, to the extent appropriate, incorporate specific language developed by the ACSBD Legislative workgroup and adopted by the ACSBD in February 2018. Principles to guide changes to laws, regulations and policies related to student behavior and discipline include:

- A. Laws related to behavior of students shall include language clarifying the expectation for schools to provide a multi-tiered continuum of evidence-based and data-driven behavioral interventions that support the behavioral competence, social development and emotional learning of all students.
- B. Remove explicit zero tolerance mandates that tie the hands of teachers administrators and school boards; excepting weapons, drugs, serious bodily injury and crimes of violence.
- C. Ensure all disciplinary statutes apply to all public schools receiving MFP funding.
- D. Clarify the role of the Louisiana Department of Education in providing leadership and support for schools with regards to student behavior, discipline and school climate.
- E. Enhance format and structure of 17:416 to group like items together with the goal of improving readability.
