Minutes

5. On the motion of Dr. Henderson, seconded by Sen. Talbot, the Computer Science Education Advisory Commission endorsed the Computer Science Education Advisory Commission Report with the following recommendations:
 - Change second bullet of the Certification Requirements subsection to read as “Provide current 6-12 teachers the option of using the Praxis II Computer Science Content exam (5652) or a micro-credential portfolio to add a computer science certification to a 6-12 Louisiana teaching license and teach computer science courses that would fulfill the credit requirements of Louisiana R.S. 17:5025(5)(b).”
 - In the Additional Recommendations section of the report, include success metrics in the state wide computer science plan to measure overall effectiveness of the plan.
6. On the motion of Ms. Lively, seconded by Dr. Warren, the Computer Science Education Advisory Commission made a motion to cancel the August 2, 2023 meeting.
