Outstanding School Support Employees Award Overview



Outstanding School Support Employees Award

- The <u>Outstanding School Support Employee Award</u> provides the opportunity to acknowledge those support employees who have rendered time and talents beyond the call of duty.
- All school systems are encouraged to select up to three support staff, one per division (elementary, middle and high) as their local-level honorees and submit these candidates to the state process.





Outstanding School Support Employee Award

The nominee must be an employee of a Louisiana public school system and serve in a position that does not require a teacher's certificate as a condition of employment.



*Other includes local public school board employees who are not required to hold a teacher's certificate as a condition of employment

Outstanding School Support Application Process



Nomination Process

- Part of the nomination process includes nominations from teachers, principals, district employees, parents, colleagues, and community members.
- The nominations portal is open and will close on October 12.
- Upon portal close, the nomination information will be shared with school systems for their consideration.
- Nomination portal link



School System Selections

- All school systems are encouraged to select up to three support staff, one for elementary, middle and high, to move to the state process.
- School systems may utilize their own process to identify their support staff selections. For those who don't have a process in place, these selections may come from the nominations information.
- When the application portal opens, school systems will be notified.
- School systems are to report their selections are by November 30.

School Health Service Provider of the Year Award




Outstanding School Health Service Provider Award

- Student health plays a vital role in education and that school health providers are the critical link in ensuring health service delivery to students.
- Provides an opportunity to acknowledge school health service providers who demonstrate superior provision of health services in schools and support the expansion of health services in schools.



Outstanding School Support Employee Award

The nominee must be an employed or contracted by a Louisiana school and have a license or certification to practice in the school setting.




School Health Service Provider of the Year Award Application

The application includes:

- Basic information including name, email and school system
- Applicant provider type (nurse, OT, PT, speech, etc.)
- License type (LMSW, LOTR, DPT, etc.)
- Written responses to essay questions (500 maximum word count per response)
- Links to websites as demonstration of work may be included
- Link(s) to accomplishments that showcase work may be included
