#### **FAFSA Policy Change**

The FAFSA policy has changed. The graduation cohort of 2024-2025 and beyond are not required to complete the FAFSA as a part of their graduation checkout. This policy change doesn't remove the requirement of local education agencies (LEAs) to provide students and their parents or guardians with information regarding financial aid programs to support postsecondary education and training. LEAs must ensure that each student receives adequate support in completing and submitting an application for financial aid. However, a student action related to FAFSA completion will not be required.
