Education Bills and Policy Updates: School Attendance

Education Bills Passed: School Attendance

- **ACT 386 - House Bill 629**
 - Requires parents of truant student to ensure the student makes up missed work. Requires parent to meet monthly until work is complete.
- **ACT 674 - House Bill 46**
 - Prohibits requiring COVID19 vaccine for enrollment or attendance.
- **ACT 675 - House Bill 47**
 - Requires immunization communication include exemption information.
- **ACT 460 - House Bill 908**
 - Prohibit discrimination against students on basis of vaccination status.

Policy Updates: School Attendance

- [Bulletin 126](#), Charter Schools and [Bulletin 741](#), Louisiana Handbook for School Administrators
- Absences and attendance
 - Refines the types of absences to excused, unexcused, and suspension/expulsion.
 - Provides for implementation of daily student attendance reporting
 - Provides for reporting on truancy.

Your Safety Matters

- School safety initiatives must include extension services such as home visits.
- The safety of all CWAs and attendance stakeholders is a priority.
- A safe environment facilitates an atmosphere of effectiveness.
- All CWA Offices should have a Home Visit Safety Plan:
 - New hire training
 - Professional development/Refresher

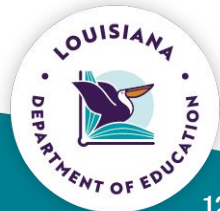

Foundational Safety Measures

- Make sure your home visit schedule/calendar is up to date with addresses and phone numbers.
- Schedule appointments during daylight hours.
- Google map/drive by the home prior to initial visit.
- If you are uncomfortable with the area partner-up.
- Make sure your plan includes law enforcement agencies invested in community policing.
- Make sure your vehicle is in good condition (runs well, tires are good, full tank of gas, roadside assistance).

Before Leaving the Office

- Review family information
- Provide logistics of your visit(s) to your team
 - Team home visit tracker
- Make sure your cell phone is fully charged
- Pre-fill all documents you may need the family to sign
- “Gut Check!” - This can happen at any point of a home visit

Entering the Home

- Check your surroundings as you arrive
- Park in the direction in which you plan to exit; avoid parking spots where you can be blocked in
- Check for animals before entering gates; make a noise and look for postings/warning signs
- Explain who you are and show identification
- If you are invited in, allow the family member to lead; keep them in front of you
- Always opt for a well lit space close to the exit
- Ask if anyone else is currently in the home and/or if they are expecting company (explain how knowing relates to confidentiality)

During the Visit

- Ask for permission to have a seat if they sit; stay standing if they choose to stand.
- Explain the purpose of the visit. Remind the family you are there to understand their barriers to attendance and work with them to address those issues.
- Observe their abilities and the environment
 - Should the visit continue? - Gut Check
 - Anger or aggressive behavior
 - Intoxication/under the influence

Ending the Visit

- Let the family know what to expect after this visit
- Go through all forms you need them to sign
- Make sure they know how to contact you if they have additional questions
- Have your keys already in your hands when leaving
- Alert a team member you are leaving via text or call
- Check the inside of your car before you get in

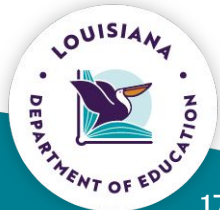
Debrief

- Document unusual or unsafe conditions.
- Discuss concerns with your team.
- Develop strategies to address those concerns for future visits in that area.

- What is home visit health protocol?

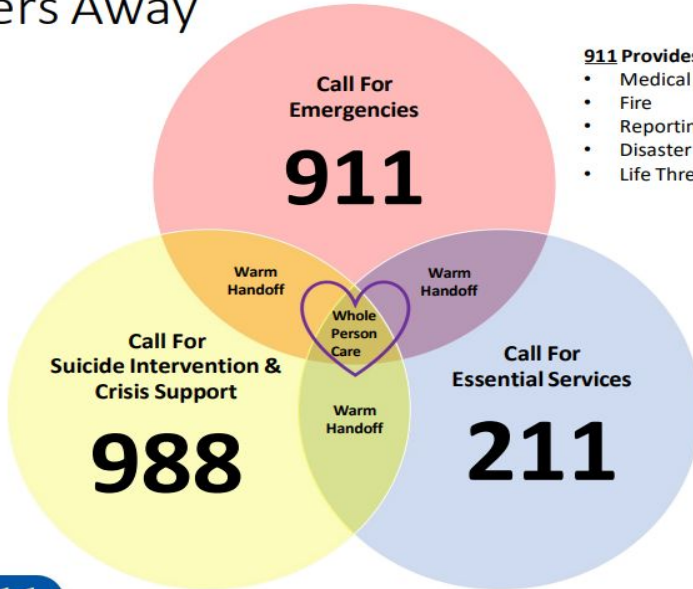
