





## **Annual Dyslexia Reporting**

School systems are required to annually report the number of students with dyslexia currently enrolled and the number of students newly identified with dyslexia in the prior school year.

### **DIBELS Progress Monitoring**

- Research has demonstrated that when teachers use student progress monitoring, students learn more, teacher decision making improves, and students develop more ownership of their performance.
- It is recommended that school systems establish routines and procedures for progress monitoring on a **weekly** basis for students falling in the "Well Below" category according to DIBELS assessment data on a weekly basis.
- For students who fall in the "Below" category, it is recommended that progress monitoring is conducted every 10 instructional days, or bi-weekly.

Recommended professional development sessions to strengthen fidelity of administration and strengthen responsiveness to literacy screener data

#### **Purpose and Participants**

The purpose of this document is to provide a comprehensive professional development plan for increasing fidelity of administration and strengthening instructional responsivemes to DIBELS literacy screener data in order to improve student literacy outcomes. The content and pacing of the series is strategically designed for deviacorts based on the mandated Louisiana literacy screener benchmark assessments. All literacy ducators and school leaders who support K-3 elementary students can benefit from completion of the professional development essions.

#### Plan for Implementation

Session titles, session descriptions, and a suggested timeline for completion are provided to support school leaders with the effective implementation of the DIBELS tittary screener. While some sessions are available through the <u>DIBELS PD Jubrary</u> other sessions can be accessed through the Louisiana Literacy Library and through the <u>DIBELS PD Series</u> on Canopy. The sessions and courseverk can be completed as part of an individualized professional growth plan, or they may be embedded in a variety of ways, including school professional development days, onboarding of newly hired aducators, and teacher collaboration meetings. Additionally, it is recommended that educators strategically revisit these topics as needed to target and strengthen areas for schoolwide growth and to promote positive systemic change.





### **Progress Monitoring Fidelity Report**


- The <u>Progress Monitoring Fidelity Report</u> will show the percentage of the student population that scored within a specific performance band and were administered progress monitoring during a given time.
- This report shows the fidelity of progress administration "at a glance" and can support system leaders in identifying teachers who may need additional resources for progress monitoring.





### **Correlation Report**

The <u>Correlation Report</u> tracks student performance over time on a specific measure, or it can be used to compare student performance on two different measures.

### Best Practices for Administering DIBELS Benchmark Assessments

Additional recommendations for the administration of DIBELS Benchmark assessments (BOY, MOY, EOY)

#### **Overview and Purpose**

This document is intended to highlight recommendations and best practices for the successful administration of DIELS Benchmark assessments to all K-3 students. The Louisian Department of Education has selected mCLASS\* with DIELS\* 8th Edition, an integrated literacy system based on the Science of Reading, as the states K-3 literacy assessment, mCLASS has been customized to meet the needs of Louisiana, based on the latest reasorch and the Science of Reading. It is a valid and reliable assessment, supporting universal literacy screening, creating of dyslexia, and progress monitoring. The <u>Test Administration Manual for BOY and MOY</u> provides information and instructions about assessment abunding and the CLASS DIELS to Bit Edition State Administered K-S Literacy Screener for Louisian at BOY and MOY. Additionally, the <u>Test Coordinator Manual (TCM) for BOY and MOY</u> provides a review of relevant information for District and School Test Coordinators at BOY and MOY.

### **Benchmark Assessments**

Louisians state law requires that all students in grades kindergarten through third grade be screened by a single statewide screener during the first 30 days of school, in bocember and in April. This screener serves as an indicator of whether core instruction is meeting the needs of the majority of students and can also be used to identify which students may be at risk for experiencing reading difficulties so that tachers can provide timely and effective support. The iteracy screener also assists in beintifying students for further evaluation for specific programming, including students who display characteristics of being dyslexic or gifted.

### **Family Engagement**

A famity is modvement can be key to a student's educational achievement. For students identified as needing an <u>individual Academis Support Plan</u>, Louisina education policy requires families to be informed about activities they can do to support estended learning at home. Accordingly, teachers should print and send home a copy of the DBELS Home Connect letter andaw with resources found under the <u>Families</u> <u>Lateracy Plans</u> and family resources connected to high-quality instructional materials. Each DIBELS Home Connect letter contains results for all Benchmark assessments administred to a student set using mCLASS during the current school year. These letters serve many purposes and are aimed at enhancing students' learning outcomes by providing information about the student's results for each completel measure.

## Aspiring Educators Attending 2025 Teacher Leader Summit

### **Credential Clearance for Educator Certification**

Starting **January 1, 2025**, Louisiana law (<u>R.S. 17:8.9</u>) requires criminal background checks (CBCs) for **certification**.

A CBC will be required before a certificate can be issued, renewed, advanced, or modified.

Certification processes, forms, and technology are being revised to integrate the CBC requirement.

Certification applications submitted before January 1, 2025 will be processed **without** additional CBC requirements.
