


# LACUE Annual Conference Call for Proposals and Registration

Registration is also open. Early bird pricing ends on October 27.




# Cybersecurity Awareness and Digital Citizenship Resources






## **Technology Readiness (TRT) Data Request**

Part 1: A Comprehensive Starting Guide - Monday, September 18th from 1PM to 2PM

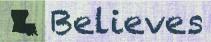
This session will cover the benefits of cyber insurance, different policy types, an overview of policy triggers, and how to successfully apply for coverage.


#### Senate Approves Anna Gomez as Fifth FCC Commissioner

On Sept. 7, the U.S. Senate officially confirmed the appointment of Anna Gomez as the fifth FCC Commissioner to a position that has been open for two years. Ms. Gomez is a telecommunications attorney who had previously worked at the FCC, had served in private practice, and is currently a communication policy advisor at the U.S. State Department.



#### ECF for 2021-2023 Window 3 Applicants

USAC has processed \$550 million in post-commitment funding reductions. This reduction should permit funding of all remaining Window 3 applicants, regardless of discount rate. It will also permit the FCC to approve waivers for certain late-filed ECF applications




#### **E-Rate Systems Consolidation Transition Dates**

USAC is consolidating its E-Rate SL Legacy systems into the E-Rate Productivity Center (EPC). All E-Rate invoicing related forms – the FCC Forms 472 (Billed Entity Applicant Reimbursement (BEAR)), 473 (Service Provider Annual Certification (SPAC)), and 474 (Service Provider Invoice (SPI) and (eSPI)) – will be moved into EPC as part of this consolidation effort. System cutover from the SL Legacy systems into EPC is expected to occur between October 30, 2023 and November 7, 2023.


Access to EPC will be unavailable for all users between October 30, 2023 at 7:30 p.m. and November 7, 2023.

Be sure to request an invoice deadline extension if you believe you will not meet the deadline, or if your current invoice filing deadline date is between October 30, 2023 and November 7, 2023.



#### **E-Rate Systems Consolidation Transition Dates**

- The last day you can submit an invoice in the SL Legacy systems is October 30, 2023, at 6:30 p.m. CST.
- Invoices for Funding Year (FY) 2016 and later that are submitted in SL Legacy systems before October 30, 2023, and not paid by the cutover date will be migrated into EPC by USAC.
- Invoices for FY2015 and earlier submitted in SL Legacy systems before October 30, 2023, will
  continue to be processed in the SL Legacy systems.
- You must submit FY2016 and later invoices in EPC beginning on November 7, 2023.
- For FY2015 and earlier, users will need to create a customer service case in EPC and attach a
  fillable FCC Form 472 or 474 to process a new request for reimbursement for FY2015 and
  earlier funding years. USAC will provide the links to the forms and instructions on its website
  in the coming weeks.
- After the E-Rate systems consolidation is completed, the first disbursements from EPC-processed requests for reimbursement are expected to be on November 9, 2023.




### E-Rate e-Learning Modules (eLMs)

To support the transition from SL Legacy systems to EPC, USAC is also rolling out e-Learning modules (eLMs) for applicants and service providers so they can learn how to submit E-Rate invoices (FCC Forms 472/BEAR and 474/SPI) using EPC when the system consolidation is complete. The eLMs will be available October 3, 2023 on the <u>E-Rate Videos page</u>.



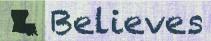

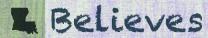
#### **E-Rate Upcoming Deadlines**


- **September 25** Due date for comments on the FCC's Further Notice of Proposed Rulemaking portion of (FCC 23-56) regarding additional rule changes to simplify E-rate. Reply comments are due October 23rd.
- **September 25** Due date for comments on the FCC's Notice of Proposed Rulemaking (<u>FCC 23-65</u>) on cybersecurity labeling for internet devices.
- October 2 Last day to receive service or to submit a Service Delivery Deadline request for FY 2022 non-recurring services. (Note: September 30th, the normal Service Delivery Deadline, falls on a Saturday this year.)
- October 24 Nominations are due for six positions, including one school representative, on the USAC Board of Directors (see DA 23-753).
- October 30 E-rate invoice deadline for FY 2022 recurring services. (*Note: October 28th, the normal invoice deadline, falls on a Saturday this year.*)



## **E-Rate Upcoming Deadlines**

- October 30 ECF invoice deadline for most Window 1 and Window 2 committed FRNs with service delivery deadlines of June 30, 2023. For details on other upcoming invoice deadlines, see USAC's Emergency Connectivity Fund Invoice Deadline Tool.
- October 30 The first Form 486 deadline for FY 2023, for FCDLs issued on or before July 1st (i.e., Waves 1-9).







## **New Al Information Being Released**

In May, The U.S. Department of Education's Office of Education Technology released a publications on <u>Artificial Intelligence and the Future of Teaching and Learning</u> and <u>Al and the Future of Teaching and Learning</u>: <u>Engaging Educators</u>

- The new policy report stresses the essential role of knowledge dissemination, educator engagement, and the enhancement of technological strategies and policies for the incorporation of AI in education.
- It portrays AI as a swiftly evolving suite of technologies adept at identifying data patterns and executing automated tasks.
- Furthermore, it assists educators in discerning the potential of these up-and-coming technologies in promoting educational objectives, while also assessing and mitigating prominent risks.

This will not be a policy guide on if schools should include or ban AI but information to assist school systems on understanding the AI landscape to inform future policies.
