- 9/30 Final Periodic Expense Reports (PERs): Submitted on or before November 15, 2023

Continue assessing the amount of ESSER II funding left for drawdown and planned expenditures through 9/30/23

- Amend the Achieve! application in order to submit claims on or before November 15
- Move ESSER III expenditures that have not yet been reimbursed that could be coded back to ESSER II funding





# **Early Childhood Updates**

The Fall 2023 CLASS® observation period has begun for early childhood classrooms at publicly-funded sites.

• Community Network Lead Agencies should be working with sites to schedule local observations and should be conducting observations.

Community Network Lead Agencies (CNLAs) have started the Fall Child Count process.

- CNLAs are working with sites to count all publicly-funded children served at each publicly-funded site as of October 1.
- Child Count provides the Department with a snapshot of enrollment in early care and education sites across the state.

## **Educator Certification New Applications**

In response to the newly adopted policy, all applications will be updated.

Beginning November 1, 2023, all applications are required to be the October 1,
 2023 version for processing.

Beginning November 1, 2023, applications will no longer be placed on hold waiting for evidence of payment.

# **Registered Apprenticeship Funding 2023-2024**

- Funding based on the number of students enrolled in either fall or spring semester in an eligible registered apprenticeship course
- \$3,500 per student school system identified as rural by the United States Census
  Bureau
- \$2,500 per student school system identified as non-rural

Funding can be utilized to support all of the costs associated with delivery of the apprenticeship services to the students.

#### New Operator Common Charter Application

- Non-profit organization without prior experience and
- Do not intend to employ an Educational Service Provider (ESP) with prior experience.

#### **Experienced Operator Common Charter Application**

- Nonprofit organizations whose founders and/or school leader have prior experience and/or
- Have one of more schools and/or
- Intend to employ an Educational Service Provider (ESP) with experience.



# **Key Dates for Local Authorizing**

- September 5, 2023: Deadline to post application materials to website
- October 27, 2023: Charter applications are due to districts
- January 19, 2024: Deadline to consider charter applications
- February 1, 2024: Deadline to notify LDOE of local board recommendations

Note: If district hasn't made a decision by January 19, the applicant is eligible to appeal to BESE.
