Technology Readiness Tool (TRT) Data Request

- In accordance with Revised Statutes [§3921.2. Statewide Educational Technology Plan](#), school systems should submit required technology information, ensuring they meet the standards for devices, Internet bandwidth, software applications, and local network capacity to provide a high-quality digital instructional environment.
- The Technology Readiness Tool (TRT) helps LDOE collect information about technology infrastructure across districts and individual schools. TRT data will be used for the school system's digital footprint, which will be published on the LDOE website and will support future technology planning.

- Data should be submitted via the [2024 TRT Collection Form](#) and was due by **November 1**. If you have not submitted, please do so as soon as possible.

EPC Administrative Window Still Open

The EPC administrative window is the period during which applicants can make updates to their profile information including student counts, National School Lunch Program (NSLP) participation rates, library square footage, and the entities and individuals associated with your entity including consulting firms, in EPC to prepare for the upcoming FY 2025 FCC Form 471 application filing window.

The administrative window opened on October 15, 2024 and will close shortly before the FY 2025 application filing window opens in early 2025. After this time, applicant profiles will be locked, and you will not be able to make changes to your profile information.

Eligible Services List (ESL) for FY25

The final version of the [FY25 Eligible Services List](#) was released on October 25, 2024. The FY 25 ESL establishes the basic eligibility rule for school and library hotspots by simply expanding the language on eligible wireless services to read:

Wireless (e.g., fixed wireless; microwave; mobile services for use on school buses; or mobile service for use with Wi-Fi hotspots).

The latest ESL also clarified school bus Wi-Fi to include basic “technical support (i.e., software updates including bug fixes and security patches, and remote technical support) appropriate to maintain reliable operation of school bus network equipment is eligible for support under Category One.

FCC Hotspot Compliance Guide

The FCC has issued a special hotspot [Small Entity Compliance Guide \(DA 24-1083\)](#) which both applicants and providers need to pay close attention to the strict usage and administrative rules. The guide's goal is to facilitate compliance and establish clear “safeguards to ensure E Rate-funded Wi-Fi hotspots and services are used for their intended purpose, including recordkeeping and usage requirements for applicants and service providers.

Safeguards fall into several categories including:

1. **Hotspot applicants will be required to:**

- a. Update and publicly post an acceptable use policy that states that the off-premises use of the Wi-Fi hotspot and/or service is “primarily for educational purposes;” and certify to meeting these requirements.

- b. Maintain an asset and service inventory that identifies the:
 - i. Equipment make/model;
 - ii. Equipment serial number;
 - iii. Full name of the person to whom the equipment was provided (for schools only);
 - iv. Dates the equipment was loaned out and returned, or the date the school was notified that the equipment was missing, lost, or damaged; and
 - v. Service detail – the line number or other unique identifier that associates a device to that particular line of service.

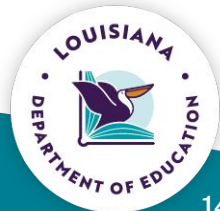

2. Applicants must work with their service providers to “establish verification processes to ensure that E-Rate-supported Wi-Fi hotspots are in use.” Specifically:
 - a. At least once every 31 days, service providers are required to determine whether any E-Rate-supported lines have zero data usage in the prior 60 days and provide notice to the applicant of those particular lines within 5 business days.
 - b. If there is zero data usage for 90 days, service providers must discontinue service to such lines.
 - c. Service providers must provide reports regarding Wi-Fi hotspot data usage for off-premises use to applicants, and applicants are required to make those reports available to program administrators and/or auditors.

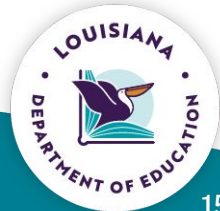

Hotspots and Bus Wifi Considerations

With the election of a new party to the White House, the FCC makeup will most likely change as the administration is allowed to appoint three commissioners to the five commissioner board. Noting both Republican commissioners strongly opposed the hotspot and bus wifi orders pushed by the three Democratic commissions, it is possible this issue may be readdressed. Noting this, applicants applying for hotspots and bus wifi need to ensure they are including provisions in their contracts that any purchases is contingent on approval of E-Rate eligibility and funding. Additionally, applicants should apply for each of these services on separate Form 471s in case these services are deemed ineligible and to not delay funding on other services.

Emergency Connectivity Fund Program

USAC has released the following three FAQs related to the congressional ECF funding recession.

Q: What is the status of the rescission following the August 29, 2024 invoice filing deadline?

A: The FCC satisfied the rescission in mid-September by returning the full \$1.768 billion to the U.S. Treasury. The FCC and USAC were then able to proceed with resolving appeals, requests for waivers, and other post-commitment transactions.

Q: When can ECF appeals and post-commitment requests be processed?

A: The restrictions on making new commitments from ECF funding should be lifted if Congress passes a government funding bill for fiscal year 2025. It is expected that the FCC and USAC will be able to resume processing appeals, requests for waivers, and other post-commitment transactions for the ECF program at that time.

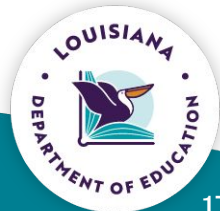


Emergency Connectivity Fund Program - cont'

Q: What impact does the continuing resolution (CR) have on the ECF program?

A: The continuing resolution (CR) that went into effect on October 1, 2024, means the FCC cannot make any new commitments from ECF funding until Congress adopts a government funding bill for fiscal year 2025. This again restricts the FCC's ability to make certain changes to existing funding commitments and in obligating any new funds, including to resolve an appeal, waiver request, or other post-commitment transaction. The CR has the effect of extending the fiscal year 2024 funding levels put in place by the government funding bill passed in March 2024, and also extends the rescission of \$1.768 billion from the ECF program. Even though the FCC has returned the full rescinded amount, without a new funding bill for fiscal year 2025, the FCC remains constrained by the ECF rescission and is prohibited from making any new commitments from the ECF funding while the CR is in effect.

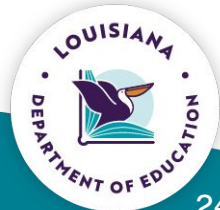
