



\*Data is from the most recent data school year 2022-2023





## Louisiana K-12 Computer Science Education Plan

The Louisiana K-12 Computer Science Education Plan is a comprehensive action plan for implementing computer science education in Louisiana.

Key Action 1	State Actions and Supports	System Actions







### **APR Monitoring Outreach**

Each year, the Division of Statewide Monitoring monitors school systems as part of the federally required annual performance report (APR).

APR outreach packages will be provided to school systems that are non-compliant or disproportionate to these requirements, including:

- Indicator 4: Discrepancies in suspension and expulsion rates by race /ethnicity
- Indicators 9 & 10: Disproportionate representation in special education by race / ethnicity
- Indicator 11: Compliance with child find evaluation timelines
- Indicator 12: Compliance with Part C to Part B transition timelines

#### Accelerate: High Dosage Tutoring Updates

- Act 771 of the 2024 legislative session requires that systems report certain metrics of High Dosage Tutoring to the LDOE in June of 2025. It is important that all systems communicate that attendance for the ten week cycles must be kept at the school level to ensure accurate reporting.
- Plan reviews are underway and many systems have received approval and are in process to receive allocations in the next several weeks.
- On-site monitoring will begin in the next few weeks; more information about what to expect from on-site monitoring will be provided later this month.

#### **Steve Carter Waitlist Update**

Due to a high level of student interest, a waitlist has been implemented for the Steve Carter Tutoring Program.

- Families may still continue to register for services, but they will be placed on the waitlist and notified of their status. Registrations will be processed on a first-come, first-served basis, and the LDOE will contact waitlisted families as soon as tutoring slots become available.
- This change will not affect families already enrolled in the program.
- Approved tutoring providers have received information about the waitlist. The LDOE will continue to accept new provider applications and they will be alerted when tutoring opportunities arise.

#### **CLSD Project Goals**

The LDOE will target the four-year grant towards four main focus areas:

- Building teacher and leader capacity around evidence-based practices in the most struggling schools and systems
- Providing targeted capacity and resources for schools serving high rates of the highest-need students
- Ensuring every child has access to a highly-effective teacher by providing literacy mentors to new teachers within three years of service in schools with high teacher turnover and/or high numbers of new teachers
- Implementing high-quality, evidence-based practices, interventions, and opportunities to support children and families

The funding will be used to serve schools that meet at least one of the following criteria:

- Chronically failing
- High teacher turnover
- High percentage of new teachers
- Growing number of English Learners
- High schools with low graduation rates
- High number of third graders at risk of retention

# Louisiana Evaluation System (LES)

## **Credential Clearance for Certification**

Effective **January 1, 2025** Louisiana law (<u>R.S. 17:8.9</u>) requires criminal background checks (CBCs) for **credentialing**. This law is much more comprehensive than what has historically been in place where the CBC was requested and required for employment purposes (<u>R.S. 17:15</u>).

A criminal history check will be required **before** a credential can be issued.


If a person has already been issued a credential prior to implementation of this new law, and the LDOE **does not have a cleared CBC** for that person, the credentialed individual will be required to complete the CBC process at the time of applying for renewal, advancement, or modification.

BESE has established policy which is still out for Notice of Intent (NOI) that defines specifics such as the acceptable age of a CBC for credentialing purposes.

# **IdentoGO** by Idemia

**IdentoGO by IDEMIA** provides a wide range of identity-related services with the primary service being the secure capture and transmission of electronic fingerprints for employment, certification, licensing and other verification purposes in professional and convenient locations.

IdentoGO has assigned the LDOE a specific agency "service code" which will be released with a waiver agreement and all disclosures when an applicant is directed to CBC process.





#### **Actions & Sanctions**

Certification may be denied, suspended, or revoked for:

- Conviction of or nolo contendere plea to a crime listed in <u>LA R.S.</u> <u>15:587.1(C)</u> even if dismissed per Article 893/894, expunged, or granted first offender pardon
- Conviction of or nolo contendere plea to **any felony** even if dismissed per Article 893/894, expunged, or granted first offender pardon
- Submitting fraudulent certification documentation to BESE or LDOE
- Facilitating cheating on any state assessment
- Censure of another professional credential/license

Reinstatement via a records review may be considered by BESE based on appeal law and policy outlined in Bulletin 746.



#### **Rap Backs**

A rap back is an updated criminal history check provided to the LDOE when there is subsequent criminal activity of individuals whose criminal background checks were completed pursuant to <u>R.S. 17:8.9</u>, the law allowing CBCs for the purposes of credentialing.

After an individual has submitted fingerprints for the purposes of a criminal background check **for credentialing**, state law allows for follow-up rap backs to be provided to the LDOE pursuant to <u>R.S. 15:587.1 B</u>. The rap backs include state information only.



# **Background Credentialing Partnership**

The new law requires a shared responsibility.

- **BESE**-establishes policies for checks, including obtaining fingerprints and requesting information from state and federal bureaus.
- **LDOE**-reviews the contents of the CBC before processing certification, making public any certification denial, suspension, and revocation.
- **Preparation Providers**-assist teacher candidates in applying for the pre-service certificates informing them of the CBC requirement.
- **Employing School Systems**-notify LDOE upon the termination, resignation, or resignation in lieu of termination of any certified employee within 10 days of separation of service when the action results from conviction for any felony or any offenses listed in R.S. 15:587.1
- Certified Individuals-required to report criminal convictions to LDOE within two business days.
