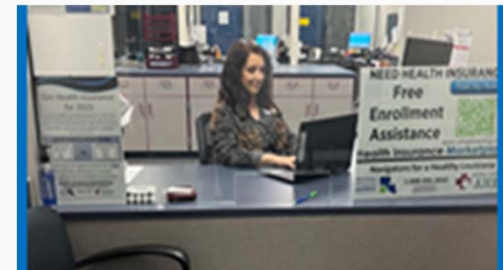
We provide:

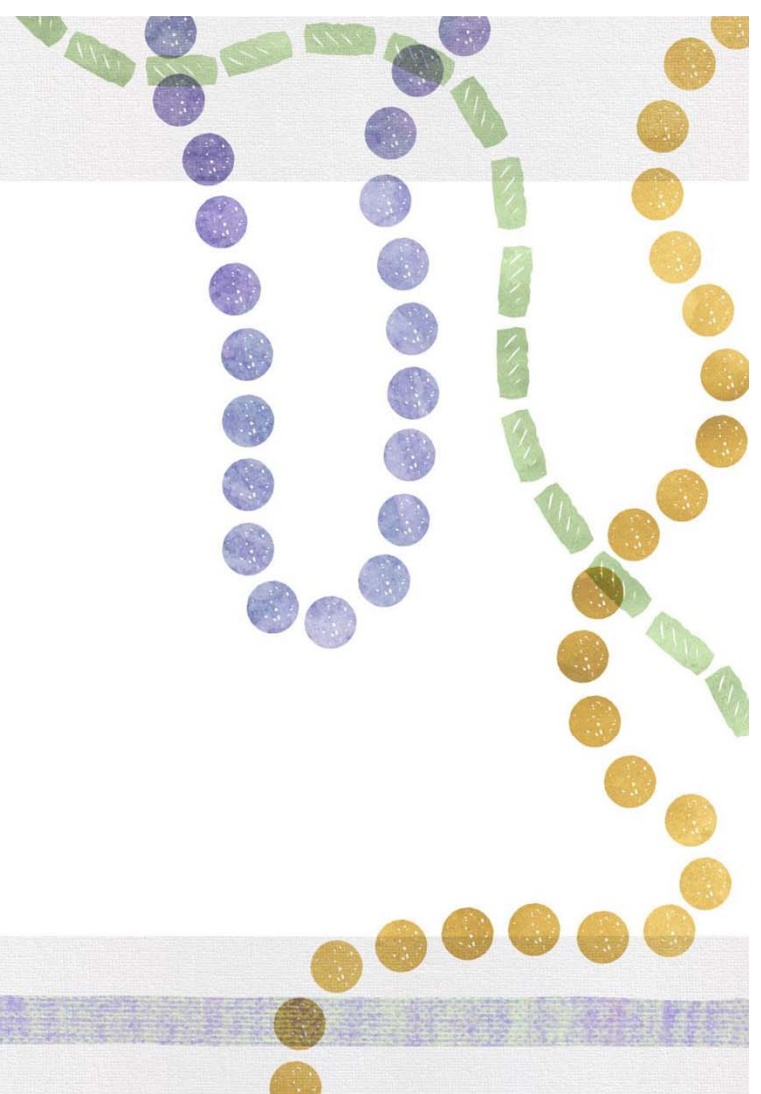

- Reimbursements are handled through CCR&R's

# Pre-K/3 2nd Edition Certification Pathway for New Observers

- For those who are not currently certified on Pre-K 2008 or K-3 2008, **their next step is to take the Pre-K/3 2nd Edition CLASS Observer Training.**
- Teachstone is offering the Pre-K/3 CLASS Observer Training for the state of Louisiana at an adjusted cost in **July** and **August**. The cost for the 3-day training is **\$500** per participant. This training is virtual and will include the trainer, materials, and reliability test. Once the test is passed, you will be Pre-K/3 2nd Ed. certified.

# Pre-K/3 2nd Edition Certification Pathway for Current Observers

For the 2023-2024 program year, all observers must be Pre-K/3 2nd Ed. Certified Observers and conduct observations using the Pre-K/3 2nd Ed. Field Guide and score sheets. To make the transition:

**Step 1** - Complete the 2nd Ed. Transition training course, either online via your dashboard or by attending a facilitated Transition Training

**Step 2** - Complete your 2nd Ed. recertification testing by activating a Pre-K/3 2nd Ed. Observer Recertification product key



# Transition Options

## Option 1: Self-Paced

Complete the **free** online transition course on your myTeachstone platform located under "Learning Hub". This is a self-paced course. There is also a PDF Pre-K/3 2nd Edition Field Guide to use as you complete the course and for your future Pre-K/3 2nd Edition reliability testing.

## Option 2: Individual Virtual Training

# Transition Options

## Option 3: Group Virtual Training

Complete the Teachstone Virtual training facilitated by a CLASS Specialist for groups of up to 20. Participants will receive a hard copy of the Pre-K/3 2nd Edition field guide and score sheets. Participants will also have the ability to get answers to any questions they have about the transition. This course is 4.5 hours and is excellent for a group with many observers. It allows everyone to be on the "same page" regarding the transition.

**Cost:** \$2,500 for up to 20 participants



# CLASS 2008 Recertification Considerations

- If you have already recertified on CLASS 2008 in 2023 and are not due to recertify until 2024, you must complete your recertification for 2nd Ed. prior to conducting any 2nd Ed. observations.
- Teachstone will offer an adjusted recertification rate of \$62.50 for those observers who fall into the category above and need to recertify on 2nd Ed in the summer or fall of 2023, prior to the fall observation period.

**Example** - I recertified on Pre-K 2008 in February 2023 and I am not due to recertify until February 2024.

I can purchase a 2nd ed. Pre-K/3 recertification product key for \$62.50 in August 2023 and complete my transition course to become a 2nd ed. Pre-K/3 observer.

My new recertification date will now become August as opposed to February.

# Data Certification Timeline

*Community Network Lead Agencies (CNLAs) must complete the Data Certification process to ensure informational metrics are accurately captured and reflected in the final Performance Profiles.*

**July 21, 2023**

CNLA receives data certification files via FTP.

Using the data certification files as a guide, CNLAs will verify data in the LDR System.

**Between July 24, 2023 and August 18, 2023**

CNLAs sign assurances by July 28, 2023.

CNLAs identify, collect, edit, and submit documentation in the LDR System.

**August 18, 2023**

CNLAs finalize edits and submit documentation in the LDR System.

LDOE verifies edits and submissions.

**August 21, 2023**

LDR System closes.

CNLAs will no longer have access to the LDR system for edits.

## B-3 Seats for 2023-2024

*Community Network Lead Agencies will receive an invitation for an extended Office Hours in the coming weeks to discuss the 2023-2024 distribution of funds to cover Birth to Three seats in their community.*

Due to additional funding received for early childhood education seats, the LDOE will be continuing the B-3 Seats pilot in 2023-2024 and will be distributing additional funds to Community Network Lead Agencies that requested seats in the most recent Coordinated Funding Request, submitted in January 2023.

Funding amounts and logic, allowable uses, and next steps will be shared at these extended office hours, which the LDOE intends to hold in August. Please look for an email invitation in the coming weeks.

Networks that have received B-3 seat funding in the past should connect with families enrolled from the previous year and ensure seats remain available in their center of choice.

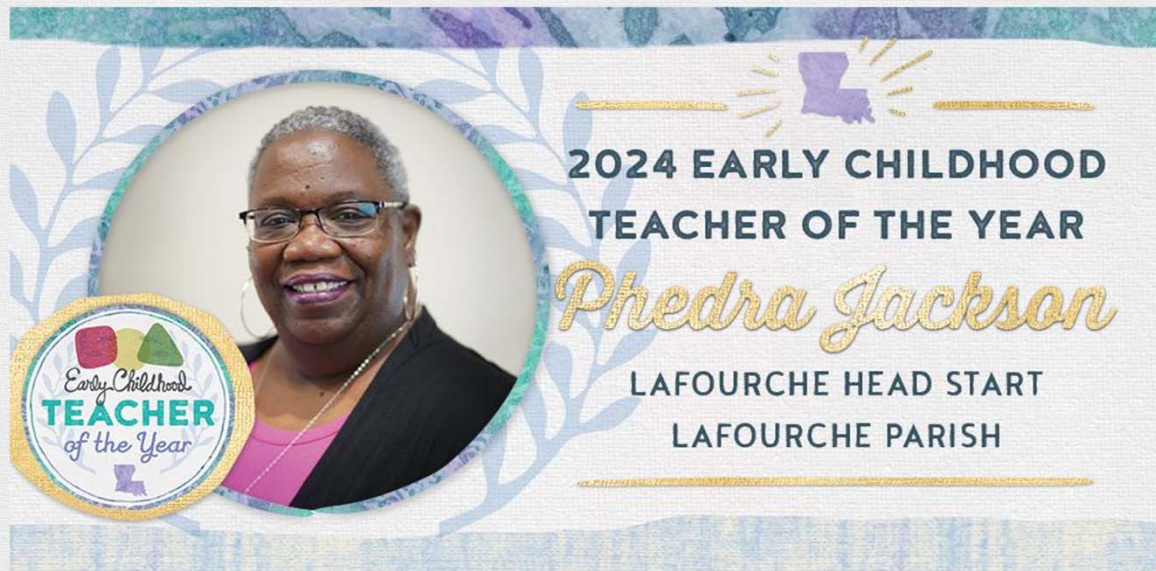

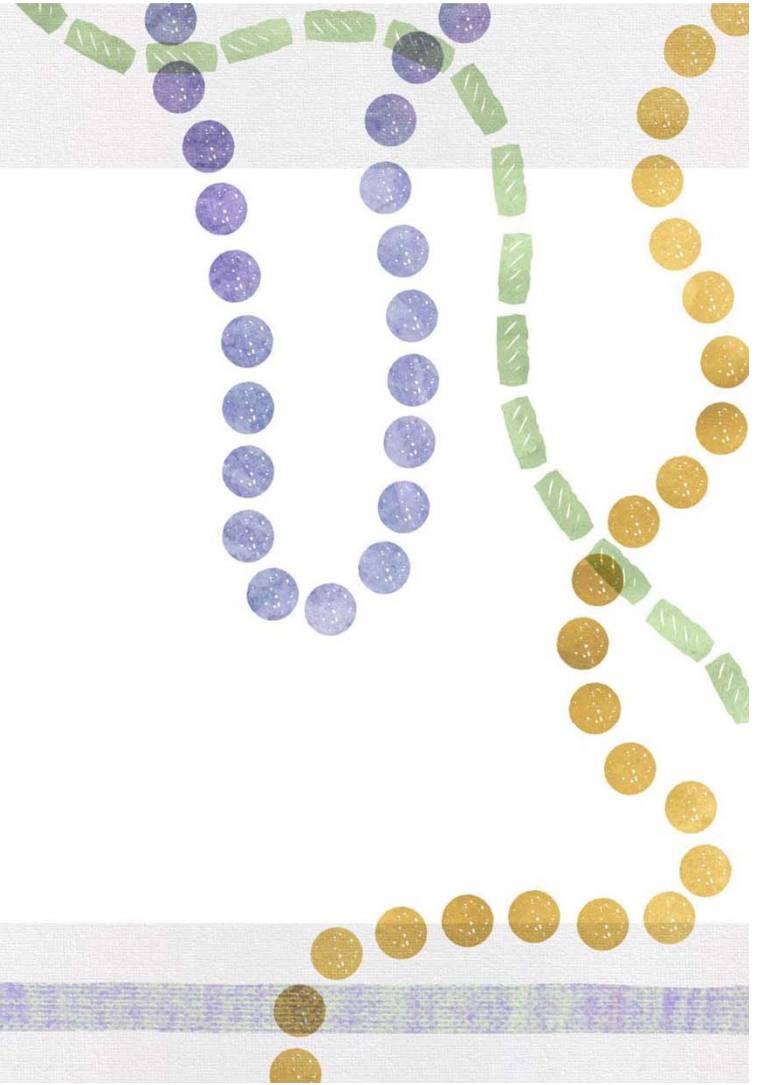
