

## **Early Childhood Updates and Reminders**Naming Shared Files Effectively

Anytime an agency submits a document to the LDOE, please include the parish name, the Community Network Lead Agency name or the CCR&R name in the name of the file.


The LDOE receives documents from all parishes every time there is a submission of an application, template, etc. due. When the name of the parish/entity is not included in the file name, documents may be lost or not credited to the correct entity.

Naming convention best practice includes:

"Parish Name Title of File 202X-202Y"

For example:

"Washington Parish ECE Fund Application 2024-2025"




## Early Childhood Updates and Reminders Early Childhood Teacher and Leader of the Year Applications


## Teaching and Learning Reminders & Updates Let's Be Healthy Grant

ECE centers can apply for a grant of up to \$2,500 to install an edible garden in their center's outdoor learning environment or to purchase small kitchen equipment.

Well-Ahead-LA is offering a new grant opportunity for child care centers to improve the health and development of children. Children who have proper nutrition and physical activity from birth are better prepared for success when they begin school. One way to do this is to nurture healthy habits by getting kids involved in growing food in an edible garden!

- Child care centers of any licensure type located in food deserts can apply to receive up to \$2,500 to purchase materials. Family Child Care sites are not eligible for this grant at this time. The deadline to apply for this grant is November 16, 2023.



# 2022-2023 Early Childhood Performance Profile Highlights




#### **Pre-K Domain Performance**




- Improvements across all domains
- Instructional Support increased 9% compared to pre-pandemic levels
- Return to pre-pandemic levels of quality.

#### **Toddler and Infant Domain Performance**




- All domains improved compared to last year
- Engaged Support for Learning increased 10% from pre-pandemic levels
- Trend of steady improvement continues.

### Performance Scores by Site Type



- Gap in scores between the average child care center and the average school is narrowing
- Centers improved more than the state overall
- Increase of 0.72 in family child care sites from initial pilot year to 2023

### **Performance Ratings Over Time**



- 93% of children are served at a high quality site compared to 87% in 2019
- For the second year in a row, there are no unsatisfactory sites statewide



## Summary of 2023-2023 Performance Profiles

- The 2022-2023 Performance Profile scores are the highest scores ever for all site types, with the most growth occurring in child care.
- Instructional Support and Engaged Support for Learning scores increased to a record high.
- More sites have earned an Excellent rating, even as the number of early learning sites in Louisiana has increased by 13%.
- There are 264 Excellent Honor Roll sites and 493 Birth to Three Honor Roll sites.

# Early Childhood Care and Education Quarter 3 Report Highlights



#### **CCAP B-3 Seats Pilot Program**

In the 2023 legislative session the Louisiana Legislature invested more than ever in early childhood care and education, enabling the Department to allocate funding for the 2023-2024 CCAP B-3 Seats Pilot program:

- In Quarter 3 the LDOE began fully transitioning the original B-3 Seats pilot into a permanent program called "CCAP B-3 Seats" with State General Funds. The Department is continuing work to codify the CCAP B-3 Seats Pilot program into policy and formally incorporate it into Louisiana's CCDF State Plan.
- Seats were allocated to 42 Community Network Lead Agencies, based on Coordinated Funding Requests from January 2023, that estimated demand for approximately 6,500 seats across those communities.

### **Early Childhood Education Fund**

Seven Community Network Lead Agencies that raised qualifying local funds for the Early Childhood Education Fund for 2023-2024 began enrolling children.

#### **Professional Development**

The Department continued to provide professional development opportunities for child care teachers across the state.

- 20 BESE-approved Early Childhood Ancillary Certificate (ECAC) Programs
  provided course content and support focused on preparing teachers for
  successful classroom interactions during this period.
- CCR&R agencies provided a total of 3,392 hours of coaching and 263 hours of training.
  - These agencies also provided 285 hours of coaching to 78 Family Child Care sites across the state that have opted into Academic Approval.
  - The training and coaching provided focused on improving teacher-child interactions, engaged support for learning, and instructional support.

- Community Network Lead Agencies are responsible for observing all classrooms that were open on Oct. 1, 2023, including FCC educators that opted into Academic Approval by Nov. 15, 2023
- Lead agencies can track observation completion via the "Reports" section of the <u>Early Childhood Portal</u>, "System Level Reports" including the Community Network CLASS® Observations Completion Report, Community Network CLASS® Observations Planned, and Community Network CLASS® Observations Missing
- Observations must be submitted in the <u>Early Childhood Portal</u> by Dec. 15, 2023
