Family Child Care (FCC)

Early Childhood Ancillary Certificate (ECAC) - Initial Certificate

ECAC Initial Application (Rev. 10/1/2023)

No Application Fee Required

The ECAC is valid for three (3) years and authorizes an individual to teach in a publicly-funded early learning center serving children age birth to five as defined in <u>R.S 17:407.33</u>. The ECAC is NOT a standard teaching certificate.

****Note**: The application must be filled in on the computer. All handwritten documents will be rejected and not processed.

Step 1:

Make a copy of the FCC Educator's Social Security Card and Driver's License/Official Photo ID and save onto the computer used to submit the application.

Step 2:

Review the chart provided below and determine how the FCC Educator will qualify for the ECAC issuance.

Qualifying Certificate or Degree	Required Evidence to Submit w/Application
Child Development Associate (CDA) Certificate	 Copy of current CDA (must be current/valid) Copy of HS Diploma or equivalent Transcript from a BESE-approved CDA program
Career Diploma (began prior to 7/1/2018)	 Copy of current career diploma (approved by <u>Pathways</u>) Copy of enrollment notification to verify when coursework began
Technical Diploma or Certificate of Technical Study in EC	 Transcript verifying completion at a BESE-approved <u>ECAC Program</u> or;

related field	• Transcript showing that enrollment began prior to 7/1/2018
Associate Degree in EC related field	 Official transcript showing the completion of an associate degree in an early childhood related field
Baccalaureate degree or higher	 Official transcript showing the completion of a bachelor's or higher degree

Step 4:

The last page of the application is the Professional Conduct Form. This form must be completed (yes/no to each question). If answering yes to a question, you must provide the required documentation necessary (stated on form).

Step 5:

Create or log into your account on the <u>educator certification portal</u> and submit your application.

ECAC Application FAQs

Q: What should I do if I've submitted my application but I haven't received anything back? **A:** Send an email to <u>Certification@la.gov</u> to inquire about the status of your application. An update will be provided and you will be guided on next steps.

Q: What is the difference between the official transcript and an unofficial copy of my transcript?

A: The official transcript will show that the degree was awarded, and the unofficial copy will not.

Q: Can I submit my own application or do I need to give my application to my CCR&R Coach? **A:** The ECAC Initial Application can be submitted by the FCC educator through the <u>educator</u> <u>certification portal</u>.
