What is the Trauma Recovery Demonstration Grant?

Grant Background

 The Louisiana Department of Education was awarded a five-year federal grant by the U.S. Department of Education to expand and deliver mental health services to students who are economically disadvantaged, academically struggling, and have experienced trauma.

Trauma Recovery Demonstration Grant

 Purpose: The purpose of the grant program is to enable preschool, elementary, or secondary students from an economically disadvantaged family who have experienced trauma and subsequently demonstrate academic, behavioral, attendance, or other issues at school to access trauma-specific treatment.

 Goal: The goal of the grant program is to increase student well-being, adaptive student behavior, school safety and academic performance by supporting trauma-specific treatment.

What is considered a traumatic event?

Traumatic Events

• Traumatic incidents may be those that occur either within or outside a school environment.

• Examples of a traumatic event may be: bullying (including cyberbullying); harassment; experiencing violence (e.g., school shootings, abuse in the home, community violence), physical, emotional or life-threatening events that have lasting adverse effects on an individual's functioning and mental, physical, social, or emotional health, suicide clusters, death of close family member, emotional neglect/abuse, family mental illness, homelessness, natural disaster, parent deployed, parent in jail, parents divorced, serious injury to self, sexual abuse and student in state custody. This list is a representation but not inclusive of all events that may be considered traumatic.

Which students are eligible?

Eligible Students

Any preschool, elementary or secondary student enrolled in a Louisiana public, charter, or private school who meets the *following three criteria:*

1. Previously documented or suspected trauma that is adversely affecting the student's academic performance/progress, attendance, and/or behavior.

- 2. Student is identified as **economically disadvantaged**.
- 3. Student cannot access public or commercial health insurance programs because services through such programs are either unavailable, insufficient, or unaffordable.

Economically Disadvantaged Criteria

- Student is eligible for reduced price meals based on the latest available data
- Family is eligible for Louisiana's food assistance program for low-income families
- Family is eligible for Louisiana's disaster food assistance program
- Family is eligible for Louisiana's program for assistance to needy families with children to assist parents in becoming self-sufficient
- Family is eligible for Louisiana's healthcare program for families and individuals with limited financial resources
- Student is an English language learner
- Student is identified as homeless or migrant pursuant to the McKinney-Vento Homeless Children and Youth Assistance Act and the Migrant Education Program within the Elementary and Secondary Education Act
- Student is incarcerated within the Office of Juvenile Justice or in an adult facility
- Student has been placed in the custody of the state

Access to Health Insurance

Student cannot access public or commercial health insurance programs because services through such programs are either unavailable, insufficient, or unaffordable.

Eligibility Criteria

- Student is uninsured, is economically disadvantaged but is ineligible for Medicaid or other federal or state-subsidized insurance programs.
- Student is insured, but trauma-specific services are not covered.
- Student is insured, but services are unaffordable because of deductible or copay.
- Student is insured, but services are unaffordable because cost of service exceeds insurance cap.

Students enrolled with Medicaid will be reviewed on a case-by-case basis

Which mental health providers are eligible?

Provider Eligibility

Providers eligible for reimbursement under the terms of this grant must be:

State licensed mental health provider

 Provide secular, neutral, non-ideological services that are non-medical in nature and meet reasonable standards for evidence-based, best practices, promising practices and/or evidence-informed trauma-specific treatment.

Trauma Response Teams (TRT)


- We suggest that each participating school form a Trauma Response Team (TRT) to oversee the implementation of the
 TRDG at the school level. This team can be the same as a school's School Building Level Committee (SBLC) or
 Well-Being Leadership Team (WBLT). At least one counselor or social worker must be on the TRT.
- TRTs have five main responsibilities:
 - Print and distribute TRDG materials, such as the staff letter and parent letter
 - Determine a list of students who the team believes has experienced trauma and would benefit from this grant program
 - Submit student referrals to LDOE by the second Friday of each month, ensuring each part of the process is complete
 - Ensure parents have the information they need to make informed decisions about participating in the grant program
 - Scan and email the LDOE any TRDG Satisfaction Surveys that a student or parent/guardian brings to school

Student Referral Process

Referrals

- Referrals for services can come from many different avenues, there is no wrong door.
 - A parent may request services on behalf of their student
 - The student may be referred by a staff member at their school
 - The student may be referred by a member of a school's School Building Level Committee (SBLC)
 - The student may receive a referral by a member of a school's Well-Being Leadership Team (WBLT)
 - The student may receive a referral from a member of the school's Trauma Response Team (TRT)
 - The student may receive a referral through Department of Children & Family Services (DCFS)
 - The student may receive a referral through a partner agency
 - A service provider may identify a student who meets eligibility criteria and is in need of services

SCHOOL-BASED REFERRAL PATHWAY



*Schools located in Ascension, City of Baker, East Baton Rouge, East Feliciana, Jefferson, City of Monroe, Pointe Coupee, St. Bernard, Tangipahoa, West Baton Rouge, West Feliciana, and Thrive Academy should consider leveraging the Graduate Intern Social Worker (when placed) to conduct the trauma screening.

There is no minimum number of students needed to participate in the grant program. The number 10 is just a suggestion.

Informed Consent to Participate in Trauma Screening

Trauma Recovery Demonstration Grant

is partnering with the Louisiana Department of Education to implement the Trauma Recovery Demonstration Grant (TRDG) program. This program will expand and deliver trauma-focused mental health services to economically disadvantaged students who have experienced trauma and are struggling academically, behaviorally and/or with consistent attendance. The goal of the TRDG program is to increase student well-being, adaptive student behavior, school safety, and academic performance by supporting trauma-specific treatment. Trauma-specific counseling will be provided to economically disadvantaged students at no cost to their family.

If your child's teacher or other school personnel administrator suspects your child may benefit from a trauma focused mental health screening, you will be notified by the school through your preferred method of notification. Your permission is required to begin the screening process (see attached Permission page). For the purposes of this project, data collection is defined as questionnaires, screenings, attendance information, as well as academic and behavioral data. If you grant permission for your child to participate in this screening, the student's information as described above will be shared with the Louisiana Department of Education. Your agreement to participate or your refusal to participate in the screening and data collection will in no way impact the services your child receives at

As part of the trauma screening and referral process, your child will be asked to complete a questionnaire administered by a school counselor or social worker to identify any potential trauma. If potential trauma is identified, you will be notified by the school and next steps will be discussed. You have the right to inspect, upon request, the survey document, and any other documents or materials used in connection with the survey, before the survey is administered to your child. All information will be kept confidential and in accordance with student safeguards defined by the Family Educational Rights and Privacy Act (FERPA), and LA Revised Statute 17.3914, or the Health Insurance Portability and Accountability Act (HIPPA), if applicable

NOTE: LDOE Student/Parent Rights and School Responsibilities

The confidentiality of the education records of all students enrolled in public schools in Louisiana are afforded protection under the Family Education Right to Privacy Act (FERPA). Every public school district is required to implement processes to protect the privacy of student information and restrict data sharing. Parents have a right, upon request, to inspect any education records pertaining to their children. LEAs are only able to share personally identifiable information about students with others as long as the data sharing meets one of the laws limited exceptions as described in the Policy Guidance. In accordance with the legislation, LEAs: (1) are prohibited from requiring the collection of non-academic data about students such as political affiliation and religious practices; (2) are permitted to share personally identifiable information under specific circumstances (e.g. LEA officials with a legitimate educational interest; Specified officials for audit or evaluation purposes; to appropriate officials in cases of health and safety emergencies.]; (3) are prohibited from allowing anyone to access student information that is stored by schools or LEAs except authorized stakeholders such as parents, teachers, principals, superintendents, or a person authorized by the state to audit student records.

Counselor Support Team (CST)

- The Counselor Support Team (CST) is a tool to aid schools in successfully referring students for the TRDG. All of their work will be done virtually.
- The CST will:
 - Answer questions related to the TRDG.
 - Administer the trauma screener when a school does not have the resources to do so.
- Counselors will be accessible during school hours, as well as after hours. In order to have a CST member administer the trauma screener, schools must make an appointment by contacting their assigned counselor.
- Once a school decides to participate in the TRDG, they will be assigned a CST member.

Trauma Screeners

• The screeners utilized by the TRDG were made by Tulane University's Department of Psychiatry and Behavioral Sciences as part of the Louisiana Child Welfare Project.

• Students 7 years of age and older must be screened using the Child and Adolescent PTSD Screen.

Children 6 years of age and younger must be screened using the Young Child PTSD
 Screen. This is to be completed by the student's parent/guardian.

Child and Adolescent PTSD Screen (CAPS-C)

- The CAPS-C Screener is to be given to students 7 years of age and older
- You must determine if the student can complete the screener on his/her/their own.
 - If the student is too young to do the screener on their own (7yrs-10yrs) or is unable due to other reasons (exreading delay), the screener is to be read aloud to the student as an interview and the items explained at the student's developmental level.
 - When reading the screener, be sure to use a matter of fact tone and exhibit a calm disposition.
 - If you would like to see an example, please watch TBH Boy Session.
- Read the instructions located at the top of the screener aloud to **every student**, making sure they understand: 1. What is considered a traumatic event and 2. What frequency means. You must do this before the student begins the screener.
- After the screener is complete, tally up the scores to determine if the student should be referred for further trauma screening.

Young Child PTSD Screen (YCPS)

- The YCPS Screener is to be given to the parent/guardian of students 6 years of age and younger.
- Ensure the parent has read the instructions located at the top of the screener, making sure they understand: 1. What is considered a traumatic event and 2. What frequency means.
- Inform the parent/guardian that they will not be scoring the screener and that they should only answer the 12 questions on page 1 and 6 questions on page 2.
- After the screener is complete, tally up the scores to determine if the student should be referred for further trauma screening.

SCHOOL-BASED REFERRAL PATHWAY

Each school forms a Trauma Response Team (TRT).

TRT comes up with 10 students who they believe may have trauma.

TRT provides students' quardians with TRDG parent letter and trauma screening consent form.

GRANTED

The school staff member gives trauma screener to 10 students.*

TRT completes the student eligibility checklist and sends via email to LDOE for review.

The staff member who completes the checklist must sign and date the form.

Forms must be submitted by the second Friday of each month.



ELIGIBLE

School supports are available to student and family.

School supports are available to student and family.

Student begins receiving services from a provider of his/her/their choice.

Parent or guardian must be present for the first treatment session.

School supports are available to student and family and/or student and family can receive services through other means.

- The packet contains information for parents as well as a list of mental health providers organized by region.
- The family will then select a mental health provider of their choice.

Trauma Recovery Demonstration Grant Mental Health Provider List

This packet contains the contact information for mental health providers participating in the Trauma Recovery Demonstration Grant (TRDG). Each mental health provider has been vetted by the Louisiana Department of Education (LDDE) to ensure he/she/they has: 1. A valid up to date license and 2. Training in trauma-informed or trauma-focused mental health treatments.

Parents and guardians are encouraged to select a mental health provider that best fits their needs. If the licensed counselor you select is not currently participating in this grant program, he/she/they will be assisted in completing the enrollment process before services begin.

Next Steps:

- 1. Select a mental health provider that best fits the needs of your student.
- Schedule an appointment with the mental health provider, stating that you were referred by the Trauma Recovery Grant. During the first visit, your student will participate in a trauma screener to finalize eligibility.
- Once eligibility is confirmed and your student is officially enrolled in the grant program, continue making appointments with your selected mental health provider as needed.

Please Note: When making an appointment, please make sure to state that you were referred by the Trauma Recovery Grant.

- □ 3. Screen student for trauma using the Child and Adolescent PTSD Screen or Young Child PTSD Screen
- ☐ 4. Complete the <u>Student Eligibility Checklist</u>
- ☐ 5. Scan and email the Student Eligibility Checklist and consent form to <u>traumarecoverygrant@LA.gov</u>
- □ 6. If LDOE confirms eligibility, provide student/family with the Mental Health Provider List and instruct them to make an appointment with a provider of their choice, stating that they were referred through the Trauma Grant.

LOUISIANA'S TRAUMA RECOVERY PROGRAM



Improving student well-being, behavior, school safety, and academic performance by supporting trauma-specific therapy sessions.

WHAT IS TRAUMA?

Traumatic incidents may happen inside or outside of school. Some examples include bullying, harassment, experiencing violence (e.g., school shootings, abuse in the home, community violence), the death of a close family member, family mental illness, homelessness, natural disasters, parent deployed, parent in jail, parents divorced, and serious injury to self.



WHICH STUDENTS ARE ELIGIBLE?

Students must meet the following characteristics:

- ✓ Enrolled in a Louisiana PreK-12 public, private or charter school
- √ Identified as low-income
- Suspected trauma that is negatively impacting the student's learning
- ✓ Payment for services is a barrier for receiving services (student is uninsured, co-pays are too expensive, and/or student is underinsured)
 - Students enrolled with Medicaid will be reviewed on a case-by-case basis.

WHO PROVIDES SERVICES?

The Trauma Grant pays for traumaspecific therapy sessions provided by an enrolled state licensed mental health professional. Each participating provider has been checked to ensure they have training in trauma-focused mental health services.

FAMILY CHOICE

Students and parents are encouraged to select a mental health provider that best fits their needs. If the licensed mental health provider you select is not participating in this grant program, they will be helped in completing the enrollment process before services begin.

If you or your student is experiencing a mental health emergency, please call 911 or go to your local emergency room.

What kind of data is LDOE collecting?

Data Collection

There are several reporting measures we will be collecting:

- Student attendance
- Student behavior
- Student academic performance

Most additional measures will be collected at the provider point-of-service.

 We must report the child and parents' overall satisfaction with services, and we must assess change over time in student well-being.

Your Role in Data Collection

- Families will be completing a TRDG Satisfaction Survey, available online and as a paper form.
- Families who choose to complete the form on paper will return the form to their child's school, who is then responsible for emailing the form to the LDOE.
- This TRDG Satisfaction Survey is then scanned and emailed to traumarecoverygrant@LA.gov with the subject line StudentName_TRDGSurvey [SECURE].
