SUBJECT: USDA Required School Lunch Match (FY2018-2019)

The United States Department of Agriculture (USDA) requires a match of state funds for the school lunch program. The match is evidenced, in part, through the Minimum Foundation Program (MFP) funds identified in each Local Education Agency's (LEA's) Annual Financial Report (AFR).

The Louisiana Department of Education calculates the match amount on an annual basis. To correlate the match requirement to the Federal School Lunch Program, the match is derived using a subset of Economically Disadvantaged (ED) data. The proportion of each LEA's Economically Disadvantaged student count on the official MFP student count date is applied to the State total match requirement to determine each LEA's required contribution.

For new entities, the proportion of the required match is determined by calculating the average Economically Disadvantaged percentage in the district of prior jurisdiction and applying it to the initial MFP funded amount. In subsequent years, the actual number of Economically Disadvantaged students will be utilized.

The attached schedule contains each LEA's required match amount for FY2018-2019 and is based on the February 1, 2018, MFP Economically Disadvantaged membership for each LEA. The match amount must be recorded in revenue keypunch code 4450 in each LEA's AFR. School Lunch Match data includes SNAP matches, Economically Disadvantaged counts for all schools regardless of CEP status, and all data is pulled from February 2.
