Program Overview



Steve Carter Literacy Tutoring: Program Overview

- Steve Carter Literacy Program provides tutoring services to Kindergarten through fifth grade public school students who are below reading proficiency to address unfinished learning.
- The Department has designated \$40 million dollars of the Elementary and Secondary School Emergency Relief (ESSER) funds toward this tutoring program.
- All tutoring services must be provided by certified teachers in early elementary or reading or those with a degree in education, English or other subject indicative of expertise in reading and literacy. Tutoring providers must also agree to complete the <u>Act 108 training</u> by December 31, 2023.
- Tutoring for Steve Carter participants is provided by LDOE approved tutoring providers.




Eligibility and Funding



Any Louisiana public school student in grades K-3 who scored below proficiency on the beginning of the year literacy screener is eligible for Steve Carter Literacy Tutoring.

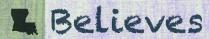
Students in grades 4-5 who scored below mastery in the ELA portion of LEAP in the spring of 2022 are also eligible for Steve Carter Literacy Tutoring.




Eligibility and Funding

Schools will identify eligible students and send a letter home to families stating eligibility. Upon family registration, eligible students will receive a \$1,000 digital tutoring voucher. This voucher will be for the year.

The voucher will be automatically uploaded into the child's account through the portal. As tutoring sessions are scheduled, the voucher will decrease until extinguished. Families will verify the tutoring sessions occurred prior to the tutor receiving payment.



Tutor Profile Set Up




Tutor Profile Set Up

In order to submit reimbursement requests, tutors must complete their tutor profile on the LDOE Steve Carter Program Portal

To complete the tutor profile, tutoring providers must visit LouisianaTutoringInitiative.com and select the Tutor/Provider button, then click next



This will direct the user to the tutor search page where tutor business name, contact name, and zip code will be searched.



Tutor Profile Set Up

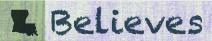
Once the tutor is located, additional data points will become visible. Any data on this screen will be sourced from the approved tutoring provider list. Any blank fields will need to be

populated prior to moving to the next page.

Upon submitting this information, the tutor contact will be required to provide the routing and checking account number that the organization would like to receive reimbursements to. An IRS Form W-9 will also need to be provided at this time.


Once this step is complete, the tutor profile setup will be complete, and the tutor can begin to submit requests for reimbursement.



Accessing Tutor Dashboard

Once the tutor profile is complete, the tutoring provider can access the Tutor Dashboard. The Tutor Dashboard can be accessed by visiting LouisianaTutoringInitiative.com and selecting "login" on the top right of the landing page.






Accessing Tutor Dashboard


This will trigger a temporary PIN that will be sent to the tutor contact's email address. The PIN will be entered into the "Temporary PIN" field. Upon selecting "Submit", the user will be directed to the Tutor Dashboard.

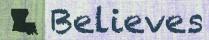


Tutor Dashboard Overview

- •The Tutor Dashboard provides an overview of the history of each student that a reimbursement request has been submitted for. This includes total funds requested, total funds approved, and total funds disbursed to date.
- •From the Tutor Dashboard, the user will also be able to create a reimbursement request for a new student and view the organization information that was provided/confirmed during the tutor profile setup.
- •If the tutor contact would like to view an individual student's details, he/she will select the student ID.

 Upon selecting the student ID, the user will be taken to the Individual Student Dashboard.

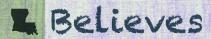




Individual Dashboard Overview

The Individual Student Dashboard allows the user to see the details of previously submitted reimbursement requests and submit new reimbursement requests for the student.

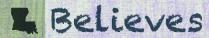

Reimbursement Requests Overview

In order to submit a new reimbursement request, the user will need to provide:

- The Student's ID
- The tutor who led the tutoring session
- Total number of students that attended the session
- Hourly rate of the session (\$40 per hour 1:1, \$30 per hour 2:1 or \$27 per hour 3:1)
- Length of session
- Total cost of the session



Reimbursement Requests Overview (cont.)

Continued:


- Description of the service (e.g., 10 minutes of phoneme segmentation, 30 minutes of decoding/encoding, 20 minutes of fluency, 1;1 with Mary)
- Type of service (In-person or virtual)
- Date of session
- Invoice that includes student ID, date of session, length of session, and total cost of the session
- •Once all information is submitted and approved, the system will trigger a notification to the student's parent/guardian to approve the reimbursement.
- •Once approved by the student's parent/guardian, the reimbursement will be processed in the next round of payments.




Steve Carter Tutor Requirements

According to Act 415, all Steve Carter Literacy Tutors must be certified teachers in elementary or reading or have a degree in education, English, or another subject indicative of expertise in reading and literacy. Tutoring providers must also agree to complete the Act 108 training by December 31, 2023.

Group Size


Face-to-face and virtual literacy tutoring group size can be up to 3 students. (Reimbursement for tutoring \$40 per hour 1:1, \$30 per hour 2:1 or \$27 per hour 3:1.)

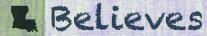
