SUBJECT: FY2022-2023 USDA Required School Lunch Match

The United States Department of Agriculture (USDA) requires an annual match of state funds for the school lunch program. The Louisiana Department of Education is provided a total state match amount by the USDA each year that must be divided into individual school system match amounts. The attached schedule contains the required match amount by school system for FY2022-2023.

The school system match amounts are calculated using the School Lunch Match data set which is a subset of the February 1 Minimum Foundation Program (MFP) Economically Disadvantaged (ED) student count data for each school system. School Lunch Match data includes Free & Reduced Lunch Counts for all schools regardless of CEP status. The School Lunch Match data for each school system is applied to the State total match amount to determine the required match contribution.

For new entities, the proportion of the required match is determined by calculating the average Economically Disadvantaged percentage in the district of prior jurisdiction and applying it to the initial MFP funded amount. In subsequent years, the actual School Lunch Match data will be utilized.

The match is evidenced, in part, through the Minimum Foundation Program (MFP) funds identified in the Annual Financial Report (AFR) for each school system. As such, the required match amount must be reported in the Annual Financial Report (AFR) at the end of the fiscal year. The match amount must be recorded in the revenue keypunch code 4450, State Public School Fund (MFP) – School Lunch in the Annual Financial Report (AFR).
