#### The application for 2023-24 Louisiana Scholarship Program will close tomorrow, January 27, 2023.

All families (including Orleans) who need to submit applications for the 2023-24 school year must apply using the LDOE website. Parents will be able to access the <u>application</u> on December 12th on our <u>website</u>.

- New applicants, students who wish to transfer to another participating scholarship school for the upcoming year, and those in a terminal grade will need to submit an application for the 2023-24 school year.

## 2023-24 School Choice Program Application

The application for 2023-24 School Choice Program for Students with Exceptionalities will open on February 1st and close on March 6th, 2023.

All families for both new and returning students will need to submit applications for the 2023-24 school year. Families must apply using the LDOE online application, which will be available on the LDOE website on **February 1st**.

# **Assessments, Accountability and Analytics**

#### **Cohort Graduation Data Certification**

Please share with accountability contacts.

The Department plans to open data certification for the 2022 graduation cohort in March. School systems should complete the following steps in advance of this certification period:

- Notify <u>assessment@la.gov</u> of any changes to the accountability contact for the school system.
   The official accountability contacts on the Department file are the only individuals who will be assigned an account in the Louisiana Data Review System.
- Check for a graduation date on the official transcript in the STS. No student will be counted as a graduate without a complete and dated transcript. School systems will be required to correct the transcript in STS during data certification before any changes are approved.
- Check to make sure all students who earned a diploma through the Jump Start Career Diploma
  Alternate Pathway have taken all three LEAP Connect subject tests at the high school level.
  Students are not eligible for this pathway without full participation in LEAP Connect.
- Check for Jump Start credentials earned by cohort members. To earn points for credentials in the strength of diploma index, credentials must be correctly recorded on the transcripts. During data certification, school systems will be required to correct the transcripts in STS before any changes are approved.
- Organize a process for collecting documentation for exit code 10 (out of state), exit code 14 (transfer to approved nonpublic school) and exit code 16 (BESE-approved home study). Students

who were exited with one of these codes and who do not have documentation will be changed to nongraduates.

#### October 1 Data Collection Deadline January 30

#### NCCER Proctor Certification Training

NCCER proctor certification will be held virtually on various dates January 30 through February 8. The cost for proctor certification is \$65. Per NCCER, all virtual classes will be 2.5 hours in length. When requesting your date and time, please make sure you can commit to the 2.5 hour time period.

#### **NCCER ICTP/Core Instructor Training**

NCCER ICTP/Core teacher certification will be held February 27 through March 3. The class will be instructed by NCCER Master Trainer Chance Plaisance. The master trainer will work with craft instructors

to complete performance profiles. The cost of the certification class for ICTP/Core is \$700.00. Registration costs will be paid directly to the trainer. Perkins and/or CDF funds can pay for training costs.

Prior to registering for the training, all potential craft instructors are required to submit documentation of skill to troy.borne@la.gov. Documentation of skill may be any or all of the following:

- Resume with experience in craft, or teaching experience in craft requested, including professional contacts to verify experience in requested craft area(s)

#### **Mentor Teacher Stipend Payments**

Per the FY2022-2023 Minimum Foundation Program formula, a stipend of \$2,000 will be provided for teacher mentors serving as assigned mentors of record, responsible for supporting undergraduate or post-baccalaureate resident teachers. The payments will be adjusted for time spent with residents. A separate payment, apart from the regular MFP monthly payment, is currently being processed. #### **Annual Educator Workforce Report Released**

Please share with system leaders, site leaders, human resource directors, and data managers.

The annual Educator Workforce report highlights the progress of Louisiana's comprehensive recruitment and retention strategy. This past year saw the following improvement:

- percentage of teachers of color increased by two percentage points;
- percentage of certified teachers increased by two percentage points;
- average teacher salary increased over \$1200;
- teacher retention rate increased by two percentage points; and
- first-year teacher retention rate increased by five percentage points.

#### Aspiring Principal Fellowship Application Open

In an effort to support the development of school leaders across the state, the Department will be launching the third cohort for aspiring principals. The Aspiring Principal Fellowship (APF) prepares EDL1 certificated individuals with the critical knowledge and skills needed to serve in the principal role.

APF cohort participants meet throughout the year and explore best practices with regional experts and school visits. Participants will exit this fellowship with a robust leadership portfolio, the guidance of Louisiana's most successful principals, and a strong network of lifelong colleagues.

Applicants must hold a current EDL1 certification in Louisiana. School systems need to cover the cost of the \$1,000 tuition for presenters and materials, as well as travel costs. Interested candidates should complete the Aspiring Principal Fellowship Application no later than March 10.
