## Scholarship Transfer Request 2023-24

The transfer window for the Louisiana Scholarship Program (LSP) and School Choice Program (SCP) reopened on August 1. All transfers for Quarter 1 must be completed by **August 25**.

## **Quarterly Scholarship Enrollment**

All schools should be currently reviewing student rosters and verifying their LEADS portal access.

We strongly encourage schools to schedule an <u>Office Hour session</u> if you have any enrollment access issues, questions regarding entering enrollment or questions about a specific student's enrollment.

Quarter 1 reporting for the Louisiana Scholarship Program (SEE) and School Choice Program (SCS) must be submitted September 1-7 in order to receive tuition payments on-time.

- If any information is incorrect or a student is missing from your roster, please contact us immediately at <u>studentscholarships@la.gov</u> for assistance.
- If the enrollment reports are not accurate and submitted on time, it affects the student enrollment counts and delays tuition payments.

- Each school is responsible for reviewing the final quarterly enrollment report as entered in the LEADS system.
- If a student drops from your school, please follow the drop procedures so that the student can be dropped from your roster.

# \*Please note that the payment report generated in LEADS does not accurately reflect final payment amounts.

Schools will have **30 days** from the last day of quarterly enrollment reporting period each quarter to report any enrollment issues.

### 2024-25 Notices of Intent for Scholarship Programs

The Notice of Intent is submitted to the Department each year in the fall by schools that wish to participate in our scholarship programs and request \*NEW\* scholarship seats for the upcoming school year.

• Schools must complete NOIs for each scholarship program even if no new seats are being requested for the upcoming year.

The 2024-25 Notices of Intent for the Louisiana Scholarship Program and the School Choice Program for Students with Exceptionalities will be available on October 1. The link to the forms will be available via email, the scholarship website, and newsletter on that date.

### Louisiana ESEA Fiscal Flexibility Waiver Request

The LDOE requested the U. S. Department of Education approve its tydings waiver to access additional flexibilities for certain funds received under the Elementary and Secondary Education Act of 1965 (ESEA).

The U. S. Department of Education approved the ESEA Waiver, which includes flexibility for the carryover limitation on FY 2022 Title I Part A funds (i.e., FY22 Title I waivers do not count against LEAs); and the period of availability of FY2021 funds for Title I Part A, B, C, and D; Title II Part A, Title III Part A, Title IV Part A and B; and Title V Part B Subpart 2 (i.e., FY21 funds now expire **September 30, 2024**, instead of September 30, 2023). ### Student Learning Target (SLT) Guidance

Please share with data managers, human resource directors, school leaders, and school system leaders.

Educators may begin setting SLTs for the 2023-2024 school year. Many resources are available in the <u>Compass Library</u> to support educators in this process. The <u>SLT Assessment Identification Guide</u> provides a list of approved assessments to assist in measuring students' attainment of learning targets. State assessments should not be used to set student learning targets. Approved literacy screeners and high-quality curriculum-based assessments are encouraged when available. The <u>S LT Guidance and</u> <u>Sample Templates</u> outline the types of targets and processes for setting targets and provide sample templates. The <u>Student Learning Target FAQ</u> answers common questions about student learning targets.

SLTs can be entered into the <u>Compass Information System (CIS)</u> following the system rollover to 2023-2024 following VAM release in October. <u>Bulletin 130</u> requires that a meeting take place between the evaluator and the evaluatee to discuss each student learning target; student learning targets not discussed in a meeting between the evaluator and evaluatee shall not be used in the evaluation.
