# **Message from the Superintendent**

#### Dear Colleagues,

Providing all students with quality math instruction from foundational to advanced skills is one of Louisiana's new education priorities. Louisiana students have improved in math since the pandemic, but that progress stalled last year. We also know that across the country and here in Louisiana, students tend to do worse in math from grades 4-8. Louisiana is working to become the state that flips that trajectory.

The national decline in math proficiency from grades 4-8 was a key data point that helped us build our comprehensive math strategy. Louisiana has set ambitious math goals for the next four years that would lead to the highest achievement levels in state history.

- Grow the percentage of students proficient and above on LEAP grade 3 Math by 10 percentage points.
- Grow the percentage of students proficient and above on LEAP grade 8 Math by 10 percentage points.
- Increase NAEP 4th grade math scaled score by 10 points.

Hundreds of Louisiana teachers are getting a special delivery from us as we emphasize the state's back to the basics approach to improving foundational math skills. We're providing over 700 math kits to targeted schools and systems. The kits include tried and true tools like flash cards. We are also personally delivering graphing calculators to high schools in various parishes. These kits connect to the state's overall math strategy and help provide students with the type of meaningful practice proven to develop foundational skills.

The math kits are the latest <u>math resources</u> we have provided educators, school and system leaders, and families. Our <u>downloadable grab and go activities for families</u> have even received national recognition.

We want to provide every student with the opportunities they need to master foundational math skills. As education leaders, it's critical to set the expectation across your system or school that every kid is a math kid. All students can master foundational, grade-level content.

In October, BESE approved an LDOE revision to bulletins regarding communication pathways. The LDOE is establishing a communication pathway for electronic delivery of information regarding key priorities and initiatives directly to each member of a local school board and to each local education agency (LEA). In short, the LDOE will begin emailing a summary of updates following each BESE meeting. Along with state KPIs and initiatives, the LDOE will also share school system-specific data related to KPIs and initiatives with each school board member.

# ACT and WorkKeys

#### Please share with school leaders and testing coordinators.

- PAST DUE: ACT MOUs are required for all school systems that administer ACT retesting or WorkKeys testing during state administrations. Please submit them to <u>assessment@la.gov</u> as soon as possible.
- WorkKeys data sharing agreements are mandatory for school systems that wish to use WorkKeys tests administered in a non-LDOE realm. The LDOE will not accept any WorkKeys documentation during data certification if a WorkKeys data sharing agreement is not in place.
- <u>Test Accessibility & Accommodations (TAA) System</u> is open for submissions for ACT Spring testing.
- The WorkKeys administration window for accommodations and supports testing closes on October 25. Testing coordinators should follow the instructions for <u>returning materials</u>. *Note:* There are two different tabs to find information based on testing mode — WorkKeys on Paper and WorkKeys Online.

# School Safety Data Submission to FTP Site

#### Please share with school principals and system leaders.

<u>Senate Bill 207. Act 334</u> of the 2023 Regular Legislative session requires LEAs and schools to submit data to the LDOE:

- The local school superintendent is required to provide an annual report to the public school governing authority on the status of the crisis management and response plan of each school under the governing authority's jurisdiction. They shall submit a copy of the report to the LDOE and the Center for Safe Schools.
- Each public school principal is responsible for providing in-service training, which may be incorporated into a meeting or training session held for another purpose, for all teachers and school employees pertaining to the crisis management and response plan. They shall involve local law enforcement, fire, public safety, and emergency preparedness officials in the preparation and presentation of the training. The training shall include an active shooter exercise. The training shall be reported to the local school superintendent and the LDOE.

#### Submission of Documentation:

- All documents should be submitted electronically via the LDOE's Data Management FTP site only.
- Naming conventions for individual files:
  - The school system annual status report: **SystemName\_YearAnnualStatusReport.pdf** (Example: OakSchoolSysem\_24-25AnnualStatusReport.pdf)
  - School in-service training documents (Include the agenda, agencies involved in the training, and sign-in sheets): SchoolName\_SystemName\_YearSchoolTraining.pdf (Example: AspenElem\_OakSchoolSystem\_24-25SchoolTraining.pdf)
- The Annual Status Report and School Training documents should be compiled into **one zip file** with the following naming convention: **SiteCode\_SiteName\_Year\_Program Name** (Example: 123\_OakSchoolSystem\_24-25School Safety)
- Provide the zip file to your FTP Coordinator to upload to a School Safety subfolder in the Data Management FTP.
