## Educator Talent and Workforce Development

<u>Credential Clearance with a Criminal Background Check (CBC) for Certification</u>
Please share with human resources directors, preparation providers, school leaders, system leaders, and teachers.

Effective January 1, 2025, Louisiana law (R.S. 17:8.9) requires criminal background checks (CBCs) for credentialing. This law is much more comprehensive than what has historically been in place where the CBC was requested and required for employment (R.S. 17:15).

- A CBC will be required before a credential can be issued if LDOE does not have one on file less than five years old.
- If a person has already been issued a credential prior to implementation of this new law, and the LDOE does not have a cleared CBC for that person, the credentialed individual will be required to complete the CBC process at the time of applying for renewal, advancement, or modification.

Certification applications **submitted before January 1, 2025**, will be processed without sending the applicant to be fingerprinted.

For applications **submitted on and after January 1, 2025**, the applicant will check <u>www.teachlouisiana.net</u> to see if LDOE has a CBC on file that is less than five years old. If none exist in the applicant's LDOE file or if the applicant has no certification file at all, the applicant will be directed to the Credential Clearance (CC) application packet where the individual will schedule fingerprinting with IdentoGO **BEFORE** certification can be processed. Certification applications are being updated with a new Professional Conduct form, the link to the Credential Clearance (CC) application packet, and other documents addressing certification clearance and how to determine if one exists or if the applicant will be subject to a new background check for certification.

#### **Leader Mentors Needed**

The LDOE is seeking effective school leaders to serve as mentors for the next generation of school leaders. Interested current school leaders will receive free professional development focused on supporting and coaching future school leaders.

Multiple mentoring opportunities are available and can last between three and twelve months. The LDOE will schedule some meetings, but mentors will schedule the majority at their convenience, which can occur virtually or in-person.

Mentoring future leaders is a core component of the new alternative pathway into principalship recently approved by BESE (EDL Pathway 4). Active educational leaders interested in compensated mentoring of future leaders while gaining professional development should complete an application.

#### 2023-2024 Evaluation Close-Out

Please share with data managers, human resource directors, school leaders, and systems leaders.

The deadline to enter or <u>upload</u> 2023-2024 evaluation data into <u>CIS</u> for teachers, counselors, and other instructional staff is November 29. Leader evaluations will be due following the release of School Performance Scores (SPS) later this winter.

As a reminder, all 2024-2025 evaluation data should be entered directly into LES for all schools, regardless of the chosen evaluation type; there will be no transfer of scores or spreadsheet uploads in the new system.

#### **Louisiana Evaluation System (LES)**

LES is live and all 2024-2025 evaluation data (observations, SLTs, PGP/Coaching Plan) for educators can now be entered. Even if using legacy systems (COMPASS or approved alternate observation tools) rather than transitioning to LEADS, data will be entered into LES. LES system contacts are encouraged to collaborate with human resources and data managers to ensure that educators are able to <u>access</u> LES. ### **Teacher Preparation Quality Rating System Performance Profile Release**

Please share with teachers, systems leaders, school leaders, human resources (HR) directors, and preparation providers.

2022-2023 Teacher Preparation Quality Rating System (TPQRS) Performance Profiles were released at the October 2024 BESE meeting. The performance profiles contain information on each BESE-approved teacher preparation program's overall quality rating and individual domain ratings. The domains included in the overall score are: 1.) Preparation Program Experience, 2.) Meeting Educator Workforce Needs, and 3.) Teacher Quality. This information can be used to make informed decisions as systems support newly hired teachers as they enter the workforce as well as assisting systems to select post-baccalaureate programs for certification of candidates. ## **School System Board Member BESE Updates**

In October, BESE approved an LDOE revision to bulletins regarding communication pathways. The LDOE is establishing a communication pathway for electronic delivery of information regarding key priorities and initiatives directly to each member of a local school board and to each local education agency (LEA). In short, the LDOE will begin emailing a summary of updates following each BESE meeting. Along with state KPIs and initiatives, the LDOE will also share school system-specific data related to KPIs and initiatives with each school board member.

#### **Local-Authorizer Reporting Requirements**

On October 25, 2024, all Type 1 and 3 applications were due to local authorizers. Local Authorization are required to report the following information regarding charter applications received in their district:

- Non-Profit Foundation Name of Applicant
- Proposed Charter School Name
- Name of Primary Applicant
- Date Application Submitted

Information regarding applicants being considered by local-authorizers was due to LDOE by November 11, 2024 using the Jotform <u>link</u>. Additionally, local-authorizers are required to notify state legislators of charter applications received within each district.

Per August 2024 Bulletin 126 update, applicants are now also required to report their submission to the local authorizer and may use the Jotform <u>link</u>. Please provide this information to any applicant who has submitted for the 2024-2025 RFA process.

Decisions regarding approval or denial of each applicant are due to LDOE by January 31, 2025.

#### 2024-2025 Nonpublic School Annual Reporting Due

The annual enrollment report window for all nonpublic schools approved by BESE (Private Schools Seeking State Approval) to submit their school's 2024-2025 annual enrollment data closed on October 15. Prior to completing your school's NPS annual enrollment report, the school administrator that will be entering the data is required to set up an EdLink account and request the "NPS School Manager Role." # **School System Financial Services**

#### 70% Instructional Expenditure Requirement

Please share with business managers and financial officials.

Per the MFP Resolution, school systems must ensure that 70% of the local school system general fund expenditures are in the areas of instruction, pupil and instructional support, and school administration at the school building level. Compliance with this expenditure requirement is calculated annually. The results of FY 2022-23 70% Instructional Expenditure Requirement are available via the edFin FTP site. BESE will receive a report of the results for all school systems at the January 2025 meeting. Systems that are not in compliance with this requirement will be required to submit a Corrective Action Plan to the Office of School Systems Financial Services by December 4.
