## **The New Teacher Experience: Professional Learning Modules**

**Please share with all school leaders, system leaders, and new teachers.**

The LDOE, in partnership with A+PEL, has developed monthly professional learning modules on topics that are critical for new teacher success. These modules include online asynchronous content followed by an in-person learning lab where participants practice and apply these concepts. Teachers are expected to complete the entire series of Professional Learning Modules. These five modules are designed to build learning throughout the year.

- Module 1: Classroom Management/Classroom Environment
- Module 2: Standards and Curriculum
- Module 3: Data Literacy
- Module 4: Literacy for 21st Century Learners
- Module 5: Parent and Community Engagement

This year, complimentary seating for the first 245 registrants will be offered. Half of the seats for the northern location (Monroe) and half for the southern location (Port Allen) will be reserved as complementary seating. Once those seats are exhausted, teachers may still attend but there will be a cost of \$1,272.00 per teacher to complete the series of modules.

Teachers will be asked to receive approval to attend from their school leader. Registration will open July 30. The link for registration and detailed logistics will be available in next week's newsletter. Once teachers complete the registration, participants will receive details on selected training locations. Participants will also receive an invitation to access the online asynchronous modules.

## **EDL Alternative Pathway 4 LDOE Training**

The EDL Alternative Pathway, as detailed in Title 28, Part 81, Subchapter A, offers a unique opportunity for current MPA, MBA, or JD holders and honorably discharged commissioned officers from the US military to obtain an Educational Leadership Certificate. To be eligible, individuals must complete training provided by the LDOE, and pass either the Praxis School Leader Licensure Assessment or the Louisiana Leadership Assessment Series.

The pathway requirements state that candidates must be provided a mentor to support their induction and transition into the Educational Leadership role. The LDOE is currently seeking mentors to support these candidates.

### **K-3 Literacy Beginning-of-Year Screening**

The mCLASS screening platform will open for DIBELS administration functions July 25. Testing coordinators will be able to begin setting up classes and test administrators. Actual screening dates have been customized based on each school system's first 30 days of school. Testing manuals will be available on the [Louisiana mCLASS](#) page beginning July 25.

- All sections of DIBELS must be completed for students to receive a composite score.
- All new test administrators must complete DIBELS training that is available on the Louisiana mCLASS page in the professional development section.
- All test administrators must attend a general test administration and test security training prior to administering the screener.

District test coordinators were provided with DTC webinar information via email and attached FAQ from Jennifer Baird. The link should not be shared, instead, DTCs are responsible for redelivery of the webinar to appropriate school system personnel.

CDF funds support increased student access to high-value Career and Technical Education courses and training. CDF funds are 6% of the MFP State and Local Base Cost Per Pupil (\$241) provided for each qualifying student course enrollment in grades 9-12.

### **LCTCS IBC Prior Credit Matrix**

The Louisiana Technical and Community College System has established a [policy](#) to award college credits for prior learning based on educational or work experience. This policy allows students enrolled in degree or certificate programs to earn credits through evaluations of their non-traditional learning, such as CLEP, AP, military training, industry certifications, and work experience portfolios. Each LCTCS college must publicly list eligible courses, required credits, and assessment standards, with no fee for credit reviews included in the [system's matrix](#). The policy aims to recognize and credit students' existing knowledge and skills.

### **MFP Forward Funding**

Charter schools may request MFP forward funding for significant increases in student enrollment that occur from February 1, 2024 to October 1, 2024. Schools must demonstrate that the financial health of the school will be impacted if the student enrollment increase is not recognized with an adjustment to the MFP monthly payments sooner than the March 2025 Mid-Year payment adjustments.

## **FY 2024-2025 MFP Tutoring Allocation**

**Please share with business managers.**

A \$30 million dollar appropriation was provided for High Dosage Tutoring in the 2024 Regular Session of the Legislature in order to fund the requirements of Act 771. All schools funded with MFP funds that serve Kindergarten through Grade 5 will receive a system level allocation based on the number of students with Spring 2024 score of Well Below or Below Benchmark for Grades K - 2 plus the number of students with 2023 scores of Unsatisfactory, Approaching Basic, and Basic for ELA and Math.
