ESSER ARP ConAdmin Waiver

Please share with business managers, federal program directors, and superintendents.

Due to Louisiana's continued focus on ensuring all ARP ESSER funding is obligated and drawn down within the period of availability, the agency is requesting the U. S. Department of Education approve its ESSER ARP Consolidated Administration waiver. This waiver will allow the LDOE to ensure the selected programs can continue to advance student academic achievement by allowing the LDOE to use funds reserved for administration to address ongoing administrative costs (i.e. ESSER monitoring, ESSER data reporting, etc.) and avoid diverting funds away from critical services for LEAs, schools, students, teachers, and other educational staff.

LDOE is requesting the waiver, pursuant section 8401 of the Elementary and Secondary Education Act of 1965 (ESEA).

Federal program directors, business managers, financial officials, and relevant personnel of public school systems should review this waiver request and submit all questions or comments by July 12.

English Language Proficiency Screener (ELPS)

Please share with testing coordinators and EL supervisors.

Federal law requires that students who indicate a need for English language support be screened within their first 30 days of enrollment. The English Language Proficiency Screener (ELPS) is used in Louisiana to conduct this screening. The ELPT will not be available from July 15-31 to allow for updates in the TIDE system. It will reopen on August 1. TIDE access is granted in each school system by the district test coordinator.

<u>Standard Response Protocol (SRP) and Standard Reunification Method (SRM) Train the</u> Trainer Workshop

Please share system administrator, school principals, emergency preparedness and safety personnel.

<u>Registration</u> is open for this full day Train the Trainer Workshop that will introduce participants to the history, concepts and functionality of the SRP and SRM and how to train the programs internally.

Participants will walk away from the workshop with an understanding of how the SRP provides a proven, action-based enhancement to all-hazards school safety planning. After learning about the five actions of the SRP, and their associated directives, participants will be able to implement the program and enhance the safety plans of the school system.

Additionally, participants will gain an understanding of the proven methods for planning, practicing and achieving a successful reunification using the SRM. Participants will leave the workshop with the ability to organize a reunification team in their school system and create an effective reunification plan.

MFP Forward Funding

Charter schools may request MFP forward funding for significant increases in student enrollment that may occur from February 1 to October 1. Schools must demonstrate that the financial health of the school will be impacted if the student enrollment increase is not recognized with an adjustment in the MFP monthly payment sooner than the March 2025 MId-Year adjustments.

To apply for increased monthly payments for documented growth prior to the October 1 count, please refer to the Charter School Library.

SPED Fellow Academy Cohort 5

SPED Fellow Academy is a year-long, comprehensive development program for novice special education leaders across the state. The fellowship will provide in-person training, coaching, and a community of practice that will instill the knowledge and skills the next generation of leaders need to lead and sustain change to improve outcomes for students with disabilities. Throughout the program, fellows will engage in an Executive Learning Project which is a framework for leading systems-level change to improve educational outcomes for students with disabilities. At the conclusion of the program, fellows will present their Executive Learning Projects to a panel of experts during the final colloquium. Mentor-coaches will provide expert coaching to fellows in the development and implementation of their Executive Learning Projects. Upon successful completion of SPED Fellow Academy, fellows will obtain a SPED Fellow Distinction on their EDL (education leader) certificate.
