### Educator Talent and Workforce Development

#### **The New Teacher Experience - Professional Learning Modules**

The LDOE, in partnership with A+PEL, has developed monthly professional learning modules on topics that are critical for new teacher success. These modules include online asynchronous content followed by an in-person learning lab where participants practice and apply these concepts.

Teachers are expected to complete the entire series of [Professional Learning Modules](#). These five modules are designed to build learning throughout the year.

- Module 1: Classroom Management/Classroom Environment
- Module 2: Standards and Curriculum
- Module 3: Data Literacy

- Module 4: Literacy for 21st-Century Learners
- Module 5: Parent and Community Engagement

This year, complimentary seating will be offered for the first 245 registrants. Half of the seats for the northern location (Monroe) and half for the southern location (Port Allen) will be reserved as complimentary seating. Once those seats are exhausted, teachers may still attend, but the cost to complete the series of modules will be \$1,272.00 per teacher.

## Tutoring

### **Steve Carter Tutoring Program**

The Steve Carter Literacy Program provides \$1,500 vouchers to families of eligible K-12 public school students per school year. The digital vouchers can be used to purchase high-quality literacy and math tutoring to be held after school hours, in-person or virtually. Families will apply through the [Steve Carter Tutoring portal](#) and, if approved, will select an approved tutoring provider. **PLEASE NOTE:** School administrators should be prepared to provide families with their child's 10-digit Louisiana Student ID (LASID) number, which will be required in order to complete the Steve Carter Tutoring application.

### **Accelerate: High Dosage Tutoring**

**Please share with content supervisors, literacy coaches, system leaders, school leaders, school administrators, and teachers.**

Act 771 requires all students in grades K-5 who failed to achieve mastery on any statewide assessment in reading or math to be eligible for expanded academic support. It requires one of the following:

- Prioritized placement in a class taught by a teacher labeled as “highly effective”
- High Dosage Tutoring

School systems received an allocation notice with a projected amount of funding. School System plans are due **September 15** in EGMS and should include:

- Salary and benefits for full or part time LEA staff
- External tutoring provider (on LDOE vendor guide)

### **Individual Academic Support Plan (IASP)**

This single plan replaces the Individual Academic Improvement Plan and further meets the requirements of the Expanded Academic Support Plan (high dosage tutoring plan), Individual Reading Improvement Plan, Literacy Improvement Plan, and the Numeracy Improvement Plan. ### **K-3 Literacy Screening**

All students must be screened by the last day of the designated window. This year scores from the alternate assessment, LAAR, will be reported in mCLASS. There will be no score uploads at all to EdLink. When the window closes, there will be no possibility of an extension.

### **LEAP State Placement Test**

All students who transfer from nonpublic school, home study, or out of state, and who do not have a LEAP score from 2023-2024 must take the grade 4 or 8 state placement test if they are enrolling in grades 5 or 9.
