#### **Bayou Bridges: Grades 4 and 5 Implementation Pilot Report**

During the 2023-2024 school year, the LDOE offered school systems the opportunity to participate in the [Bayou Bridges](#) Grade 4 and 5 implementation pilot. Eight school systems participated: Bossier, Caddo, St. Charles, Central, InspireNOLA, St. Landry, West Baton Rouge, and Zachary. The pilot consisted of teachers participating in professional learning, implementing materials, and participating in focus groups to share feedback.

## **Educator Talent and Workforce Development**

### **The New Teacher Experience - Professional Learning Modules**

The LDOE, in partnership with A+PEL, has developed monthly professional learning modules on topics that are critical for new teacher success. These modules include online asynchronous content followed by an in-person learning lab where participants practice and apply these concepts.

Teachers are expected to complete the entire series of Professional Learning Modules. These five modules are designed to build learning throughout the year.

- Module 1: Classroom Management/Classroom Environment
- Module 2: Standards and Curriculum
- Module 3: Data Literacy
- Module 4: Literacy for 21st-Century Learners
- Module 5: Parent and Community Engagement

This year, complimentary seating for the first 245 registrants will be offered. Half of the seats for the northern location (Monroe) and half for the southern location (Port Allen) will be reserved as complementary seating. Once those seats are exhausted, teachers may still attend, but there will be a cost of \$1,272.00 per teacher to complete the series of modules.

Teachers will need to receive approval to attend from their school leader. [Registration](#) is now open. Once teachers complete the registration, participants will receive details on selected training locations and an invitation to access the online asynchronous modules.

### **R.S. 17:3921.3 Digital Devices Guidelines**

These guidelines have been developed to provide school systems with health and safety resources relative to best practices for the effective integration of digital devices in public schools. The resources are not exhaustive but are intended to provide school systems with age-appropriate time and usage guidelines regarding various digital devices.

### **Career Development Fund End-of-Year Reporting**

The [2023-2024 Career Development Fund \(CDF\) End-of-Year Expenditure Report](#) is available for school systems to complete. The deadline to report on 2023-2024 CDF expenditures is August 31. When completing the form, school systems should reference the [2023-2024 Guidelines for Use of CDF Allocation](#).

CDF funds support increased student access to high-value Career and Technical Education courses and training. Examples of allowable expenses include transportation, tuition, teacher trainings towards the attainment of Jump Start credentials, and internship expenses not covered by partner businesses. CDF funds are 6% of the MFP State and Local Base Cost Per Pupil (\$241) provided for each qualifying student course enrollment in grades 9-12.

## **ESSER III Obligations Due**

LEAs must complete or update the ESSER III Obligations tab in the Achieve! application on or before August 30. By completing this tab, the LEA is identifying the amount of ESSER III funding that will not be obligated on or before September 30.

At the close of business on August 30, the LDOE will identify all amounts of ESSER III funding that will not be obligated on or before September 30. The amount(s) identified by each LEA will be removed from the respective LEA's total allocation amount in the Achieve! application, so it is imperative that the "Projected Remaining Balance" amounts provided on the ESSER Obligations tab for ESSER III Formula, Incentive, and Evidenced-Based funding are accurate.

#### **2025-2026 BESE and Brumfield v Dodd Approval Application**

Nonpublic Schools Seeking State Approval must apply annually for approval by the Board of Elementary and Secondary Education. To become eligible for state and federal funding, schools must be approved by the Board of Elementary and Secondary Education (BESE) and also comply with Brumfield v Dodd, a federal court order that prohibits discrimination.
