## **NAEP**

The National Center for Education Statistics (NCES) will proceed with administering the mandated mathematics and reading assessments.

- For 2022, at the state level, the National Assessment of Educational Progress (NAEP) will be administered in mathematics and reading at grades 4 and 8. The NAEP 2022 school sample will represent the 2022 student population while also maximizing overlap with the NAEP 2021 school sample.
- NCES has extended the assessment window by four weeks to end on March 31, 2022, which allows for assessment schedule adjustments when necessary.
- The NAEP 2022 administration will continue to include three assessment programs.
  - **January 10 to March 18, 2022:** National long-term trend mathematics and reading assessments: age 9
  - **January 24 to March 31, 2022**
    - State-level mathematics and reading assessments: grades 4 and 8
    - National civics and U.S. history assessments: grade 8

Under the Every Student Succeeds Act (ESSA), any school system with more than 1.0 percent of students participating in the ELA, math or science alternate assessment must take certain actions. The Department provided school systems with the following alternate assessment documents via FTP:

- Alternate Assessment Participation Data (SY 2020-2021)
- Alternate Assessment Participation Review Letter (SY 2020-2021)
- Alternate Assessment Participation Justification Form (SY 2020-2021)
- Alternate Assessment Participation Review Request and Assurances Form (SY 2020-2021)

## Educator Development

### **Professional Practice Scores 2021-2022**

BESE approved a proposal moving through the formal rulemaking process this October for the 2021-2022 academic year only regarding observations. Only one formal observation for the 2021-2022 academic year is required for those who earn a rating of *Highly Effective* or *Effective: Proficient* (score of 2.5 or higher) on the first observation.

Individuals earning *Highly Effective* or *Effective: Proficient* on the first observation can receive a second observation upon request. Any teacher or administrator who earns an observation rating of *Ineffective* or *Effective: Emerging* (2.4 or lower) will require two observations.

### **CLASS® Conversion Scores**
