

## Assessments, Accountability, and Analytics

### LEAP 2025

Please share with district test coordinators.

- LEAP 2025 Field Test: DTCs for school systems that have schools selected for LEAP 2025 grades 5-8 science and/or social studies field tests were notified by email. Test session times for field tests are available in the [LEAP-at-a-Glance document](#) posted in the assessment library.
- Third year assessment cohort rosters will be posted to the ftp by Wednesday, March 30.
  - All students in high school grades must take an ELA, math assessment to meet federal law. The third year cohort rosters are designed to identify students who have not taken English I or II and/or Algebra I/Geometry.
  - Students must test even if they have not been enrolled in the course.
  - Students who transfer in from out of state, nonpublic school or home study with a credit do not have to test. The credit should be appropriately recorded in STS.
  - Students who participated in LEAP Connect in 2022 or a prior year do not have to test.
  - Test coordinators should not remove any third year assessment cohort students from DRC INSIGHT. The students must be tested or placed in a test session and assigned an accountability code if one can be documented.
- March 28: LEAP grades 3-8 test administration manuals delivered to school systems..

### ACT

- Now-March 31: Create and assign student to test sessions for the March 22-31 testing window
- Now- March 31: Precache test content for Testing Window 2 (if utilizing proctor caching)
- March 29-31: Administer ACT online with standard time or accommodations and supports for Window 2.
- March 31: After testing is complete, purge all cached test content from proctor caching computers
- Now-April 1: Administer ACT paper with accommodations and/or supports and non-college reportable tests (test only on weekdays)
- April 8: Deadline for accommodated paper materials to be returned to ACT to be scored. Late arriving materials will not be scored.

### Innovative Assessment Program School Systems

- The *LEAP Testing Roster for IAP Schools* will be posted to the ftp by Wednesday, March 30. This roster includes students who have missed Window 1 and/or Window 2 of the IAP and will be required to participate in the LEAP 2025 grade 7 ELA assessment. Please note that students must participate in all three testing windows in order to receive an IAP end of year report. All students in grade 7 must have either an IAP end-of-year assessment score or a LEAP ELA grade 7 assessment score from the current year.

## **2021-2022 Teacher Roster Verification for VAM**

The [Curriculum Verification and Results \(CVR\) Reporting Portal](#) roster verification ensures that teachers are assigned to the correct courses and classroom rosters of students for the purposes of value-added (VAM) analysis. The data in CVR will be used to calculate a teacher's VAM score even if the teacher and/or the principal do not verify the roster. Teachers instructing ELA, Math, Social Studies (grades 4-8), and Algebra I, Geometry, English I and English II EOC courses (all grades) should verify their rosters as they are eligible to receive VAM scores.

- **Monday, April 4-Friday, April 22, 2022: CVR Open for View-only**

During this time, users can view and check roster data for accuracy, but cannot make changes in the CVR Portal. System Support will be available to assist with any issues that a school system must correct in EdLink 360.

- **Monday, May 2-Friday, May 20, 2022 (3 weeks): CVR Open for Roster Verification**

This process is required and allows teachers and principals the ability to verify and correct records for specific courses and students. Data managers will track verification completion at the school system and school level in the system.

## **Social Studies Assessment Advisory Group**

The Division of Assessment Content is accepting applications for a Social Studies Assessments Advisory Group in addition to ongoing assessment development committees. The group will be comprised of social studies educators, primarily classroom teachers and coordinators. They will provide input as the Department develops new LEAP Social Studies assessments aligned to the 2022 Louisiana Standards for Social Studies and related assessment resources.

The advisory group will convene over the course of two academic school years, 2022-2023 and 2023-2024. There will be approximately six to eight meetings per year. All meetings will be held virtually after school for no more than two hours. Participation is entirely voluntary.

### **Social Studies Source Review Committees**

The Division of Assessment Content plans to convene Social Studies Source Review Committees for grades 3–8 and high school Civics. Each committee will

- include 4–6 social studies educators, primarily classroom teachers with extensive content knowledge or grade-level expertise;
- review proposed sources to ensure that materials are fair and appropriate for all students and will support the development of items that allow students to demonstrate their knowledge and skills in social studies and align to the 2022 Louisiana Standards for Social Studies;
- convene for the first time in summer 2022 and on a regular basis during the 2022–2023 school year; and
- complete synchronous and asynchronous reviews during the 2022–2023 school year, with approximately 5 to 6 virtual meetings held outside of school hours.

### **Educator Workforce Reports**

The 2021-2022 Educator Workforce Report will be released as a live dashboard with information that is updated in real-time. The data release will shift to real-time reports in lieu of annual, static reporting. The dashboard will be released and housed on EdLink 360 by early summer. EdLink 360 Workforce Reports will:

- Grant access for system and school leaders, as well as data managers, to real-time workforce data
- Provide data inclusive of Out-of-Field/Uncertified teachers; salary over time; incentive pay over time; experience of departing teachers; effectiveness of departing teachers; certified teacher need for students with disabilities; percentage of SPED classes being taught by certified teachers

### **CLASS® Train-the-Trainer Funding Opportunity**

During the 2022-2023 school year, schools are encouraged to choose CLASS® or NIET (Tap/Best Practices) as an option to replace Compass for [K-2 Professional Practice](#).

Maintaining trained, certified observers is an important component sustaining the use of CLASS® in K-2. Funding is available for the [CLASS® Observer Train-the-Trainer](#) model for systems with CIR/UJR-A schools. At the school system level, the Train-the-Trainer model will allow school system leaders to build and sustain a cadre of certified observers.

Systems are asked to complete the [K-2 Professional Practice Information Survey](#) to provide information on current K-2 teacher observation rubrics and to help allocate seats for affiliate training.

## **CIS End of Year Closeout for Teacher Evaluations**

**Please share with systems leaders, school leaders, human resource directors, and data directors.**

The Department has issued a [CIS Timeline](#) to guide all school systems through the evaluation process deadlines for the 2021-2022 school year. To create a streamlined teacher evaluation upload process at the end of the year, it is recommended that all sites complete the following tasks in [CIS](#):

- Update rosters to reflect only 2021-2022 educators
- Assign evaluators and correct evaluation types to each educator
- Assign SLTs to each educator

The Compass Information System (CIS) will shut down for the 2021-2022 school year on September 1, 2022. Following this date, no teacher evaluation data for the 2021-2022 school year will be able to be amended or added. Please prepare to complete the following no later than August 26, 2022, in [CIS](#):

- Rate both SLTs for teachers and staff
- Enter professional practice scores for teachers and staff (A reminder that any teacher scoring a 2.5 or above is only required to have one professional practice score for the 2021-2022 school year only. This will be entered two times to ensure the CIS average is correct. Further guidance will be forthcoming.)
- Once data is uploaded, finalize teacher evaluations

## **Recruitment, Recovery, and Retention Listening Session Nominations**

The Louisiana Department of Education (LDOE) will be hosting a series of listening sessions across the state in response to the Teacher Recruitment, Recovery, and Retention Task Force Preliminary Report. The listening sessions will provide the opportunity for stakeholders to describe their experiences and perceptions as well as offer suggestions on issues related to teacher recruitment, recovery, and retention. Stakeholders will include teachers, support staff, principals, district central office staff, superintendents, student teachers/teacher residents, teacher preparation providers, and parents/guardians of students. Each stakeholder group will participate in a facilitated listening session led by the Region 14 Comprehensive Center, an outside organization that is a partner with the LDOE in improving education in our state.

In addition to indicating interest in participation, we will ask that superintendents recommend chief talent officers, human resource directors, school principals, and teacher preparation providers from your parish for subsequent focus groups. From your recommendations, the Region 14 Comprehensive Center will ask participating school principals to recommend teachers and support staff who will be featured in the first listening sessions. It is important that the listening sessions include representation from across our state. To that end, the Region 14 Comprehensive Center will review inquiries from interested stakeholders to ensure representation. ## **Aspiring Principal Fellowship**

In order to prepare future principals for success in their first year as a principal, the Aspiring Principal Fellowship will support the development of aspiring school leaders across the state. The Louisiana Department of Education launched a pilot cohort in 2021-2022 for aspiring principals and is expanding the Aspiring Principal Fellowship for the 2022-2023 school year. The fellowship will prepare up to 50 individuals with the critical knowledge and skills needed to serve in the principal role. This selective statewide fellowship is rooted in Louisiana's five priorities:

1. Ensure every student is on track to a professional career, college degree, or service.
2. Remove barriers and create equitable, inclusive learning experiences for all children.
3. Provide the highest quality teaching and learning environment.
4. Develop and retain a diverse, highly effective educator workforce.
5. Cultivate high-impact systems, structures, and partnerships

APF cohort participants will meet monthly (Orientation at Teacher Leader Summit, commencing monthly in September) and explore best practices with regional experts, school visits, and reflection. Participants will exit this fellowship with a robust leadership portfolio, the guidance of Louisiana's most successful principals, and a strong network of lifelong colleagues.

Applicants must hold a current EDL1 certification in Louisiana. School systems need to cover the cost of the \$1000 tuition for presenters and materials, as well as travel costs. Interested candidates should complete the [Aspiring Principal Fellowship Application](#) no later than April 30.

6. Equity should be at the forefront of all these strategies.

## **Ready to Achieve Operational Guidelines Masking and Transportation Update**

**Please share with system leaders, site administrators and school nurses.**

The Louisiana Department of Health and the CDC released COVID-19 Community Levels to help communities and individuals make masking decisions based on their local context.

- Universal masking is recommended for any school in a parish with a High Community Level.
- Schools may continue to require universal masking regardless of Community Level.
- Individuals attending schools that do not require masking may choose to mask regardless of Community Level.
- School buses are no longer included in the federal mask requirement for transit.
- Schools should use Community Levels to determine their policy for wearing masks on school buses, but can continue to require universal masking regardless of Community Level.

[Community Levels](#) should be checked weekly to evaluate the need for masking in school systems.
