# CHARTER SCHOOLS

**May 11, 2022**

The Louisiana Department of Education recognizes that student health plays a vital role in education and that school health providers are the critical link in ensuring health service delivery to students. This year, the Department launched the [School Health Service Provider of the Year program](#), which celebrates some of the state's most exceptional school health service providers. Each of the finalists demonstrates expertise in their field, advocacy for students, a clear commitment to collaboration with their community, and growth of their school health program.

The Department will honor one finalist in these four areas: Occupational/Physical Therapy, Speech/Audiology, Nursing, and Behavioral Health. Of those four finalists, one provider will be chosen to receive the School Health Service Provider of the Year Award.

All four finalists will be recognized at the June 15 BESE meeting in Baton Rouge.

## Assessments, Accountability and Analytics

### **EdLink Accountability Dashboard Launch**

**Please share with school and system leaders.**

In an effort to provide more impactful and integrated data analytics, the Accountability Dashboard has now launched in EdLink 360. This Accountability Dashboard replaces the Principal & Superintendent Secure Portal, which is no longer available. The Accountability Dashboard provides secure accountability data and insights for school and system leaders. In addition, the Accountability Dashboard houses a number of professional development videos focused on how school and district leaders can interpret and utilize their accountability-related data.

District security coordinators can assist users in setting up accounts within EdLink. School system and district users should request access through [EdLink Security](#). Superintendents and district-level administrators should request the District Administrator role, and Principals should request the Principal role.

- Grade 3 paper-based materials: Pickups are already scheduled for pickup of paper-based materials
- Grades 4-8
  - There are no administrative error opportunities for tests that have been voided.
  - May 25: LEAP testing window closes
- LEAP High School
  - Requests for extended hours must be made at least 24 hours in advance.
  - To schedule administrative error tests, requests must be approved by the Department with void documentation. Administrative error test scores are not used for accountability purposes.

### **Reminder: 2021-2022 Teacher Verification For VAM**

**Please share this information with teachers, principals and data managers.**

The [Curriculum Verification and Results \(CVR\) Reporting Portal](#) roster verification ensures that teachers are assigned to the correct courses and classroom rosters of students for the purposes of value-added (VAM) analysis. The data in CVR will be used to calculate a teacher's VAM score even if the teacher and/or the principal do not verify the roster. Teachers instructing ELA, Math, Science, Social Studies (grades 4-8), and Algebra I, Geometry, English I and English II EOC courses (all grades) should verify their rosters as they are eligible to receive VAM scores.

**May 2 - May 20, 2022: CVR open for roster verification**

This process is required and allows teachers and principals the ability to verify and correct records for specific courses and students. Data managers will track verification completion at the school system and school level in the system.

## **School Improvement Best Practices**

**Please share with system leaders.**

The 2022 Louisiana Best Practices [registration](#) for all general [training dates](#) is now available. LDOE has partnered with the National Institute for Excellence in Teaching (NIET) to develop, implement, and support five [School Improvement Best Practices](#). Most Best Practices [trainings](#) are two days, which must be taken consecutively, and the Teaching and Learning Standards training is four days in length. Each school can send up to five participants. Sessions will be capped for capacity to allow for facilitators to better engage with individual educators.

All CIR and UIR-A schools will be required to participate in the Instructional Leadership Team (ILT) Support and Teacher Collaboration Support training sessions, as well as the accompanying online portal and two days of on-site and/or virtual coaching as follow-up support to the training.

- If a CIR or UIR-A school participated in ILT support or Teacher Collaboration support trainings in Summer 2021, then it is required that they complete the “next level” training in that area in Summer 2022.
- If a CIR or UIR-A school did not participate in ILT support and Teacher Collaboration support trainings in Summer 2021, then it is required that they complete the “foundational” training in those areas in Summer 2022.

While all CIR and UIR-A schools are required to participate in the Instructional Leadership Team Support and Teacher Collaboration Support training sessions, all schools in Louisiana can participate in this opportunity to support implementation of these essential practices this summer.

## **Summer Learning Programs**

### **FY 2021-22 Projected Local Revenue Data**

In order to complete the FY20221-23 MFP calculations for charter schools, projected FY 2021-22 local revenue data (and expenditures related to the collection of the revenue) must be submitted to the Department by each city/parish school district. The projected FY 2021-22 local revenue data is being collected through the LEADS portal using the same process as was used in prior years. A list of the required [keypunch codes](#) and step-by-step [instructions](#) for submitting data through LEADS are provided. The LEADS data collection portal opened **May 4**. Submit this data no later than **May 18**.

Learning will cover topics such as strategic budgeting, stakeholder engagement, laws, and policies, leveraging data, and leadership development including managing teams and sustaining change. In addition to a robust curriculum, the program will support fellows in examining a systems-level problem of practice, developing a theory of action to address the problem of practice, and developing an action plan to lead systems-level change.
