# 2024-2025 Mentor Credential Waiver Application Guide



## **Mentor Waiver**

Beginning in September 2020, every teacher who serves as the Mentor of an undergraduate or post-baccalaureate candidate must hold the Mentor Ancillary Certificate or the Provisional Mentor Ancillary Certificate.

BESE has allowed a waiver of the Mentor credential for the 2020-2021, 2021-2022, 2022-2023, and 2023-2024 school years.

In April 2024 BESE approved policy to allow for Mentor waiver approval on a case by case basis.



# **Mentor Waiver Eligibility**

Mentor teacher waivers will be granted on a case-by-case basis through the application process established by the LDOE and at no fee to the applicant, school system, or teacher preparation provider. The waiver will be issued by the LDOE for educators highly recommended by the mentor's principal and who possess one or more of the following qualifications:

- Two years of Highly Effective Compass ratings;
- National Board Certification;
- Statewide or national distinction for excellence in teaching;
- Experience as a TAP mentor, master teacher, executive master teacher, or certified TAP evaluator;
- Content leader experience, as evidenced by participation in Content Leader training or redelivery of professional development; or
- Master's or doctorate in education and exemplary experience hosting student teachers.

# **Mentor Policy Updates**

At the April 2021 BESE meeting, the board approved changes to Bulletin 746 regarding mentor credential requirements. These updates include:

- Honoring Previous Training and Experience
  - EDL or previous administrative certifications
  - NIET trained evaluators
  - CLASS trained evaluators
  - Supervision of Student Teachers
- Removing the Content-Specific Assessments
- Creating an Add-On Mentor Endorsement If an educator meets one of these requirements they can follow <u>these steps</u> to apply for their Mentor certification.

# 2024-2025 Mentor Credential Waiver Application

The 2024-2025 application process is similar to the waiver application used in the 2023-2024 school year:

- System Lead creates application
- Mentor Attestation
- Principal Attestation

The application stages in the portal have been updated to improve application tracking. Stages will now reflect attestation completion.



# **2024-2025 Mentor Credential Waiver Application**

School system leads are responsible for initiating the waiver application. Mentors/Principals will receive an email notification requesting that they complete attestation forms.

Waivers granted in previous school years have expired.

We encourage any Mentor that is interested in Mentoring beyond the 2024-2025 school year to enroll with an <u>approved training provider</u> and apply for the <u>Provisional Mentor certificate</u>.





# **Mentor Policy Updates - ALTERNATE Waiver**


In April 2024 BESE also granted an Alternate Approval for those who did not meet the original waiver requirements.

An individual mutually agreed upon by the LEA and the teacher preparation program provider who does not meet one of the waiver criteria listed in the listed subsection may be approved for the waiver for a period of not more than two years.

# **Mentor Waiver ALTERNATE Application Steps**

For the 2024-2025 school year, the application process for the Mentor Alternate waiver will be completed entirely online through Surveymonkey Apply.

School system staff began the process by submitting the Mentor's name and email address, the prep provider contact's name and email address and the principal's name and email address. The application will be forwarded to all parties via email.

This application needs to be reviewed with completed attestation from the Mentor, the LEA, and the Teacher Prep Provider.

All will electronically sign the application.



## **Review Process**

Applications will be reviewed within 72 hours of completing the three tasks.

Once the application is reviewed and accepted, district personnel will see the status of each application submitted in the portal.

Approved status serves as confirmation that the applicant can serve as a Mentor in the 2024-2025 school year.

If the application is denied, school system personnel will receive notification with denial rationale.

August 1: 2024-2025 Mentor Waiver Application open

August 21: 2024-2025 Mentor Waiver ALTERNATE Application open

October 1: Funding deadline to hold Mentor Credential or Mentor Credential Waiver

June 12, 2025: 2024-2025 Mentor Waiver Application closed June 12, 2025: 2024-2025 Mentor Waiver ALTERNATE Application closed
