CONSENT ORDER

This matter was set for hearing on Monday, October 21, 2013 on the Louisiana Department of Children and Family Services' (the Department) La. R.S. 1423 removal order and request for preliminary and permanent injunctive relief. Prior to hearing, both sides reached an agreement and desired that it be made the order of this Court. Therefor,

IT IS ORDERED that defendants Kadlyn's Learning Academy, LLC, Mary A. Jones and Naquellar Joran Martin immediately cease operating the child day care facility known as Kadlyn's Learning Academy;

IT IS FURTHER ORDERED that a preliminary injunction issue, to be effective during the pendency of these proceedings, directed to defendants Kadlyn's Learning Academy, Mary A. Jones, and Naquellar Joran Martin, enjoining, restraining, and prohibiting them from operating a child day care facility during the pendency of these proceedings or until they apply for and receive a new, valid, current license to operate such a facility from the Department;

IT IS FURTHER ORDERED that defendant Mary A. Jones shall not in any manner own, operate, or participate in the ownership or operation of any child day care facility, whether directly or indirectly, or accept any children into her care or custody other than her own children or grandchildren during the pendency of these proceedings.

SO ORDERED at Amite, Louisiana, this 28 day of October, 2013.


