CONSENT ORDER

This matter was set for hearing on the State's request for a preliminary injunction to block the operation of a child day care facility without a license. Prior to hearing the parties and their attorneys reached a consent agreement and desired it be made the judgment of this Court. Considering the verified pleadings and cooperation of counsel the Court is satisfied that the proposed Order conforms to the law and the evidence. Therefore,

IT IS ORDERED that a preliminary injunction issue as requested, without bond, directed to defendants IVORY and SHEILA SIMON-MCKANSTRY, and enjoining defendants, together with their officers, agents, employees, representatives, and all others acting at their direction or on their behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services.
