



# **Graduation Ceremony Guidance**



The Office of State Fire Marshal released <u>guidance for graduation ceremonies</u> on April 27. This guidance includes the following general revisions: The capacity for any graduation ceremony shall be subject to the following per 79-JBE-2021:

• **75% capacity** of the fixed spectator seating as well as 75% of the net occupiable floor areas of the venue as defined by 1 person per every 20 square feet when all attendees and participants *are NOT required to wear face coverings for the entirety of the ceremony.* 

\*OR\*

• **100% capacity**, with no social distancing, when all attendees and participants *are* required to wear face coverings for the entirety of the ceremony



- AP Digital Testing Guide Please download and review version 2.0 of the <u>AP Digital</u> <u>Testing Guide</u>, which includes April 8 updates. The guide has been updated with expanded information about required pre-exam steps, new dashboards to help educators track student readiness for digital exams, exam day instructions for proctors, and more.
- Four Steps to Take Digital AP Exams All students taking digital AP Exams need to complete <u>four steps to get ready to test</u>. This month, students should take two key steps to get ready for digital AP Exams:
  - Step 1: Download and install the 2021 AP digital testing application and log in.
  - Step 2: Practice with example questions in the app.

# **Believe to Achieve: Louisiana ACT®NOW**

The Louisiana ACT<sup>®</sup> NOW program provides funding to purchase pre-billed ACT test vouchers for eligible students in grades 12 and 10. To receive reimbursement for vouchers, school systems shall submit a <u>completed application</u> that includes specific programmatic, physical and accountability assurances. Vouchers purchased from ACT can be used for any test administrations in Summer or Fall 2021.

The cost of vouchers for ACT without writing is \$55 per student.

# **Financial Aid Planning**

The FAFSA is the form for state and federal financial aid for postsecondary endeavors. As a requirement of the IGP planning process throughout high school, every senior, as a requirement for graduation, must complete a FAFSA or have a waiver in place. We are currently ranked second nationally. If you would like your school's rate you can visit the LOSFA <u>Compete to Complete</u> site, contact us or ask your System Relations staff.

Any waivers issued for the Financial Aid Planning graduation requirement will be reviewed during the graduation cohort verification process and must be present for students to count in the cohort graduation rate.

#### **Scholarship Award**

The Jump Start Construction Scholars program will provide up to 40 one-time scholarships in the amount of \$1,000 each to students graduating from high school with a Jump Start Diploma and NCCER Credential planning to enroll in an LCTCS program or an Associated Builders and Contractors training program. The application deadline has been extended to May 10.



# **Bulletin 741 Changes**

Per Bulletin 741 policy, beginning in the 2020-2021 school year students may earn a maximum of seven credit recovery units that may be applied towards diploma graduation requirements and no more than two Carnegie units annually. The school system must annually report to LDE the rationale for any student who exceeds these numbers on the <u>Credit Recovery Policy Reporting Form</u>.

Beginning with the 2020-2021 school year, graduating seniors must finalize Individual Graduation Plans (IGP) with the school counselor. Further, prior to being awarded a diploma from the school system, all academic records must be uploaded to the state student transcript system (STS) with a graduation date posted.
