Phase 3 Updates: Band and Vocal Music

LDOE was able to collaborate with the Office of Public Health yesterday and further identify additional flexibilities for band and vocal music that have been incorporated in our <u>FAQ document</u> and <u>School Reopening Guidance</u>

Our top focus is the health and safety of students and employees as we support systems in their efforts to reopen and operate schools. We will continually monitor the pandemic and address any necessary regulatory flexibilities to support school system instructional needs.

Phase 3 Updates: Band and Vocal Music

Phase 3: Band, Vocal and Music

- Louisiana Department of Health recommends that band and vocal music activities be held outdoors to the greatest extent possible.
- When band and vocal music classes are unable to practice outdoors during phase 3, class may be held indoors in accordance with <u>National Federation of State High School</u> <u>Associations and the National Association for Music Education Guidance</u> which has physical distancing, masking, and instrument covering provisions.
- String and percussion instruments without singing and with social distancing between band members and audience is permitted indoors throughout all phases.

The Louisiana High School Athletic Association (LHSAA) continues to adapt and move forward with fall sports for the 2020-2021 school year. The updated LHSAA regulations and guidelines are being disseminated this afternoon to:

Playground Equipment Cleaning Update

<u>Playground equipment should be cleaned daily on a regular schedule:</u>

- Create a cleaning checklist of all commonly touched surfaces that children are allowed to come into contact with on the playground; use that checklist to hit every surface when cleaning after use
- Clean this equipment similar to the way you would wipe down frequently touched surfaces in classrooms.
- Use the school's normal surface cleaning supplies to wipe down playground equipment at least daily, and during the day to the maximal extent possible. (if there is not enough surface cleaner available, using a bleach / water solution as proportionally advised by CDC guidelines in a large spray bottle could suffice)
- After wiping surfaces, let dry at least 30 seconds. With the heat, wiped surfaces should be dry within 1-2 minute
- Students and staff should wash their hands before and after outside playground use
